It is a great American tragedy when American citizens thinking they can go out and have a fun night dancing, end up being killed. Thank you."

A. WORKSHOP

1. Committee Reports

Council Member Snyder stated the following: "First off, Mr. Pannucci is in the hallway, but I wanted to commend both Frank Pannucci and Karen Haycook and the entire Recreation Department. We launched online registration with the summer recreation program and it went pretty smoothly. I am sure Council Member Furmato will add more on that. I was a user on the system and then I was monitoring throughout the day feedback from other users. All in all, it was a wonderfully favorable response. It was easy. One person said she registered 4 children for 7 different programs in 15-20 minutes. So again, kudos to Frank Pannucci and Karen Haycook and the Recreation Department for all their hard work to get that up and running.

Also you will notice on the agenda that we have received a clean community's grant. It is an amount in excess of \$40,000.00. That grant is used for programs for litter pickup removal and for education to promote clean communities, graffiti abatement and enforcement of anti-littering laws. So we are incredibly pleased that we have received this grant and again, kudos to the staff and administration of the Borough.

I am pleased to report that another grant that we talked about at our last meeting, known as Safe Streets Grant application, has been submitted. This year when we did the grant application we worked very closely with our engineer who helped us determine the best areas for this application. Hopefully this increases our likelihood for success. Fingers crossed this will be the year we get the grant.

Also a reminder that school is out, so please be careful and mindful of children on bikes and walking now that summer has begun."

Council Member Wisniewski stated the following: "I have nothing to report this month."

Council Member Thulen stated the following: "I would like to announce that we received a recovery planning report grant from the State in the amount of \$110,000.00. It will help us on 3 specific items. Number one, we are going to start working on the GIS system for the town. This will help us figure out where our assets are in the town and handle things in a more efficient manner. We are going to create our own flood plain map. Currently we use the County's flood plain map. This will help be a little more specific to our own town and then finally, help us create a pre-management plan. Which is, I am sure most of you saw during Sandy, that you have tons of debris that stays on the streets until you figure out which landfill it goes to. The plan we have now was slapped together after Sandy. This way we will have one put in place if that were to ever happen again."

Council Member DePaola stated the following: "First off I want to send my condolences to Jeff Smith's family. For those of you who do not know him, Jeff Smith was the storm ready coordinator for our Office of Emergency Management. He was always there with a smile. According to Steve Gerrity who is one of the coordinators for OEM, he said that Jeff had been with OEM for several years and had a key role in keeping Point Pleasant safe during storms. Prior to OEM, Jeff served as Point Pleasant Fire Chief for Fire Station 41 and was also a member of the Bay Head Fire Department. Jeff, thank you for your service. You may be gone, but never forgotten. My condolences go out to Jeff Smith's family. Moving along to our Police Department, we have received numerous letters this month thanking Chief Larsen and his staff for the work that they do. One in particular came from Ocean Medical Center.

Councilwoman DePaola read the letter from Diane Tornator from the Ocean Care Center which recognized Patrolman Phillips for promptly responding and assessing a situation that happened there. He made everyone feel safe and brought about a positive outcome.

That was just one of a few letters that we received from the public. This is just an indication of the job they do and how well they respond to our residents especially when they are in need. We also received a thank you for Officer's Jessie Waterson and Jeff Johnson for their response to another situation in town and I would just like to extend my thanks to these officers and to Chief Larsen for always making sure these officers have the tools necessary to do the job they do.

Moving along, we did see a little bit of an increase for 2016 in the number of calls that our police department have gotten. There wasn't a drastic increase, but definitely an increase. It definitely shows the presence of our officers around town. With the speed and traffic patrols that they have been doing especially around the schools, we are quite grateful to them.

Also, I just want to remind everyone that school is out so our Point Pleasant children and their friends, families and visitors will be out and about. I am sure you have been noticing the increase in vehicular traffic, bicycles and walkers. I just want to remind the public to be very cautious when they are driving and be on the alert for pedestrians and know that the Borough is moving forward with our program to try

and help make Point Pleasant more walkable and rideable. We are looking into programs for improvement. Please enjoy the weather and thank you for your time."

Council President Furmato stated the following: "Council Member Snyder talked about the online registration. In the first hour, there were close to 550 people registered. It really was a great success.

Another thing, the birds are gone on the Arnold Avenue property so the block has been leveled and we are trying to get some grass to grow this year."

2. Report of Mayor

Mayor Sabosik stated the following: "A rather unusual occurrence occurred over the weekend. I got a couple emails that Point Pleasant Borough was on a TV station in New York City saying that it was a great town with great events. They highlighted some of the events that we are having and that we have already had. Summerfest was a great day. Everybody enjoyed it. Everyone I believe behaved admirably. We had no problems at all. Then we went over to the for the Rotary 5K Run. We had almost 500 runners. I directed traffic I did not do the 5K run. Then, that afternoon we had the Jazz Festival. I thanked everyone coming to Point Pleasant. There were a large percentage of people who were not residents but had come to look around. Possibly we will get some new residents because some people said our town is one of the most beautiful towns they have ever been in. After the devastation of Sandy, it shows that we are definitely on our way back. By slow methodical management, we are saving the tax payers money. We are getting grant money. I am proud to announce tonight that we are a recipient of the IBOAT Grant to help us rebuild the Bay Avenue Ramp. The only thing I don't have, is they haven't decided how much they are giving us yet. It is going to take them another 2 weeks to let us know. Hopefully it will be substantial and I should have a final number by the next meeting."
