<u>STATEMENT BY COUNCIL PRESIDENT WISNIEWSKI</u>: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 13, 2017 edition of *The Ocean Star* and the January 19, 2017 edition of *The Asbury Park Press*.

1. Supporting the 2017 UDrive. UText. UPay. Distracted Driving Crackdown

Mayor Sabosik presented the Proclamation to Chief Larsen and expressed that this is a continuation of making this town safer.

B. WORKSHOP

1. Committee Reports

Council Member Thulen stated the following: "Next week we are going to have a Land Use Committee meeting. We have a couple issues coming up more to discuss with the ordinance we introduced last week. Hopefully I will have more to report at our next meeting."

Council Member Snyder stated the following: "Just a reminder to everybody, Earth Day is coming up. That is Saturday, April 22 from 12pm-4pm at Riverfront Park.

Also, our long serving Recreation Superintendent, Karen Haycook is retiring after 30 very dedicated years of service to Point Pleasant Borough. Karen really has devoted a lot of her time to the Recreation Department. One of her favorites has always been Haunts in the Park. She has a few more weeks left here, so if you see her please tell her congratulations on her retirement and wish her the best."

Council Member Furmato stated the following: "Paving has been completed on five roads. They did a good job. The five roads were Bennett, Hall, Harbor, Shore Haven Court and Juniper Road.

Also fire hydrant flushing started this week and leaf pickup also started this week."

Council Member DePaola stated the following: "I just want to say thank you to Chief Larsen and the Public Safety Committee for getting together and trying to come up with a budget that works for the Police Department and keeps our Police Department safe, our residents safe and is fair to the tax payers.

Also at Earth Day the Community Watch Organization will have a booth there. They will be collecting any unused books and children's books. If people see books that they like they can pick it up. We are calling it, recycle a book. So, drop one off and pick one up. It is a nice event and I hope everyone is able to make it to Earth Day."

Council President Wisniewski stated the following: "Tonight we are adopting our 2017 Budget. Rather than go into excruciating detail, if anyone has any questions they can just email me. We can set up a meeting to go through the details. Even though we are not fully recovered from Superstorm Sandy we have stabilized the tax rate. This year is going to be a 1.2% increase which brings the 4 year average to around 1.3% over the last 4 years and that includes the reduced retables that we are still recovering from Sandy. I give credit to our professionals, this Council and the administration for all the hard work that made that happen."

2. Report of Mayor

Mayor Sabosik stated the following: "I am going to continue down the same theme. I think if people go back a little bit in history, this town 5 or 6 years ago, all you heard about was furloughs, layoffs and all types of negativities. In the last 3 years, this administration and this Council has worked to the best of their ability to give value back to the residents. That is one of the reasons why Point Pleasant was voted the best town in Ocean County to raise a family. We have safety with our enhanced police department. We have a good business district to shop in and one of the best schools around. Let us not underestimate how important the last 3 years has been for this town with this group of individuals. They have brought stability, improvement, safety and quality of life better than any other administration in the history of this town in my humble opinion.

Tonight, up front there is some information for a couple different organizations. Please feel free to come up and take a look.

My Mayor's hours will be April 12th from 5:30pm to 6:30pm. Anybody who wishes to come and see me, come on down. A lot of people have been coming in. It is an interesting night. It is fun to be here so if you have anybody with any questions please tell them not to hesitate to come down."

D. MUNICIPAL BUDGET

1. Public Hearing and Adoption of 2017 Municipal Budget

Mayor Sabosik opened the meeting with our CFO and Auditor who were both available for questions.

Himanshu Shah, CFO thanked the Mayor and Council and all the departments of the town for their hard work and gave a short presentation on the Budget.

For the record Mr. Shah wanted it known that the Budget calls for \$19,652,119.27 in expenditures. We anticipated 2.5 million dollars and still have 1.9 million in our cash balance which is probably the highest in the past 5 years.

Meeting is opened to the public for any questions.

Seeing no hands, Mayor Sabosik asks the town Administrator to make a comment.

Frank Pannucci stated the following: "I think that it is worth mentioning that the Mayor and Council have stated that the staff has done a lot of hard work on this and they did but it is at the direction of the Mayor and Council and especially Council President Wisniewski as chair in Finance. All we are doing is picking up the ball and running with it. This Mayor and Council has really come to fruition in 2014-2015. Before that you can see a 4.9% increases, 4.7% increases, a 6% increase in 2012 and for the last 2 years, 1.4%, 1.4% and 1.1% this year. They have done what they said. They have stabilized the tax rate while not diminishing services in the Borough and that is no easy feat. The Mayor and Council really deserve a huge thank you in the work that they did in directing the staff to accomplish these goals and our budget is actually less this year than last year by over \$200,000.00. I know that you guys are pretty humble and don't like to saying that but I need to thank all of you for the work that you have put in."

Mayor Sabosik also stated that this year is the most paving that we have done in years and that basically we are providing more services at a lower cost. I think that is what is important to bring out and tell your neighbors.
