Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the November 26, 2016 edition of *The Ocean Star* and communicated to *The Asbury Park Press*.

Mayor Sabosik stated the following: "Before we start, I would like to acknowledge some of the dignitaries who are here with us today. We have our Lieutenant Governor Kim Guadagno. We have our former Councilman Brian McAlindin and Councilman Thulen from Bricktown. We have our esteemed Judge of Ocean County, the Honorable Robert Fall. Thank you for attending. Our first official act this year will be the official oath of office for Mr. Joseph Furmato given by Honorable Bob Fall."

A. OFFICIAL OATH OF OFFICE

1. Joseph Furmato, Jr. – Council Member

Councilmember Joseph Furmato stated the following: "I just want to thank everyone for making this happen. It is an honor. Thank you."

Mayor Sabosik stated the following: "While we are waiting for the paperwork to be signed, I do want to acknowledge a senior Councilman by the name of Mitch Remig. He was elected here as the youngest council member ever. The first day that I sat next to him I looked at him and I said, you are the senior member. What do you have to tell this rookie, what do we do? So, thank you Mitch. The tutelage I guess, went pretty well."

2. Michael Thulen, Jr. – Council Member

Lieutenant Governor Kim Guadagno administered the oath of office to Councilman Thulen.

Lieutenant Governor Kim Guadagno stated the following: "Let me just say good morning to everybody. It is an amazing turnout given the amount of snow that is falling right now. It is important that we acknowledge that everybody is here today because we are all going to be out over the next couple of hours. If they are not shoveling themselves, they are certainly going to be asked why the roads aren't clear. Isn't that what small town is all about. I come from a small town, the little tiny town of Monmouth Beach up the road a couple of miles and I know today is going to be a busy day for all of you. No matter how hard you try, there is always going to be somebody who wanted their car pulled out first or their road cleared first or wanted to know why the salt isn't down yet. The most important part of that oath we just gave was not the 'I swear to uphold the constitution', the most important part was the part that says 'under the authority of the people.' This board will never forget that the most important part of their oath is that they serve the people. That is what that means. To serve under the authority of the people who elected you into this position. They all feel comfortable reminding you of that on a regular basis, I am sure especially in a small town. But it is really a reminder to all of us every year that we work for these people. Not the other way around. One last thing, at re-organization, we need to thank the people that are really suffering the most, and they are the families of the people who let these guys serve on the boards. I know they are not home on weekends, I know they are not home at night, I know they are taking phone calls day and night and I know you can't go anywhere without somebody telling you to tell your husband or your wife about something going wrong in town. So the real heroes of today are the families, the children, the spouses and the partners of the people who serve. Without your support, we cannot do what we do. It just wouldn't work. So I think that if you don't mind board give your family a round of applause. Thank you all for having me here today. I look forward to helping any way I can over the next year. Thank you."
