# Report of Mayor

Mayor Sabosik stated the following: "Tonight we are going to go a little out of order. We have a very important Resolution to start with. But before I do that Resolution I have a few comments. My report is going to focus on one item, and that is law enforcement. Tonight, our council will be voting to add two individuals, Mark C. Maloney and Matthew G. Mergner to our outstanding Police Department. They will take up the banner for enforcing laws, creating a continuance of safety for our residents and hopefully starting a long and prosperous career in our town and for their families.

Our Town, when you think back it was a famous play by Thornton Wilder about love and loss and appreciating what you have when you have it. Our residents had a love for our town and then Sandy hit. Our loss was magnified not only by the materialistic loss but one of friendships and neighborhoods destroyed. Families living next to each other for decades no longer being able to. But throughout that time, our Police Department along with our volunteer services and DPW created that safe environment that enabled us to recover and stand tall. That thin blue line was tested but it did not break. They did what they were trained to do, serve and protect. They made it capable where we as Mayor and Council could go forward and rebuild our town. Together we have shown what cooperation, respect and efforts by all to make our town the best that it can be. So to the two gentlemen who are before us this evening, you are joining a team intent to create the very best for our citizens. We will give you the tools to make you the best that you can be. Our town is partly now in your hands. Protect it, cherish it, because your future is our future. God bless you all."

# C. WORKSHOP

1. Committee Reports

Council Member Snyder stated the following: "As some of you may have noticed, we have been posting our open positions online on our Borough Website in addition to our usual ways of advertising positions. I will let Councilman Furmato talk a little bit more about some of the potential hires that we have. I just wanted to say that we are thrilled to say that once again we are using our website to the best of its ability.

Also, the Environmental Commission had their regular meeting last night and this room was probably 30 degrees colder than it is today. They have a lot of great things going on and a lot of great ideas. They are working on some ways to restore the walking path and the wooded area of Community Park. They are coming up with a phased in project that is now being reviewed by the entire Environmental Commission so hopefully they will have some suggestions for us in the near future. We are hoping that we can turn this into a community project or a scout project to assist with some of the restoration. For a variety of reasons, it is not going to be a tremendous difference in the woods because there are a lot of regulations and government agencies that permits would have to be obtained. So for right now the focus is on restoration of that area. They are also already talking about themes for next year's Earth Day. Some of the ideas they have are fantastic so I cannot wait to see what they ultimately decide on.

You will see on the agenda that we have the amended recycling ordinance on for tonight. I understand that there may be some people who will not be too pleased with some of the changes but again, a lot of this is driven by the Ocean County Recycling Center. They are not just changes that we pulled out of thin air to make our residents lives more difficult. These rules are mandated from the County and are driven in part by what the Borough is allowed to do and more importantly the Borough gets fined if we don't follow these rules. So we would appreciate everybody's help in abiding by this new ordinance."

**Council Member Thulen stated the following:** "Two brief things. Currently we have two temporary part-time inspectors and a plumbing inspector. Hopefully we will have that finalized hopefully by next meeting. In the meantime they will fulfill the needs we have especially over the summer.

We got back from the Planning Board all our notes from the deck ordinance. We don't have it on the agenda for tonight but we will have it for the next meeting hopefully."

**Council Member Furmato stated the following:** "In the last three or four weeks we have been kind of having marathon meetings about roads. We have six roads completed by the County and we have four in progress and tonight's Consent Agenda we will have four more roads. We have received possibly \$300,000.00 from the Department of Transportation to put towards road construction. It is the most that

has ever been done in one year in the Borough and all these projects will be completed by the end of the year. The biggest project is Riviera Parkway. It consists of curbs and sidewalks on one side and curbs on the other side and it is going to be a real benefit to the Nellie F. Bennett School. It is probably the busiest Borough road in town."

Council Member Borowsky stated the following: "I spoke with Sheri Silversmith, the Recreation Superintendent, this afternoon and she has told me that the summer camps are all full and doing awesome. Yesterday about 75 of our Rec campers had the opportunity to take a day trip to Blue Claws Stadium. The trip was a huge success. The kids were given the opportunity to sit in the luxury box and have a buffet lunch and watch some great baseball. They all had an absolute blast. It was a great change from last year when they went and sat on the field and had to bring their own lunches. Sheri is in the process of bringing some Fall programs together. She is open to any suggestions people have and looks forward to hearing from anyone. We would like to say thanks to the DPW workers for the wonderful job they did at our beaches this year. I cannot tell you how many compliments I have received from residents that are so excited about the upgrades. I just want to say thank you to Bob and Jude and especially Mike Kralovich and his crew.

On tonight's agenda we are going to be bonding the balance of the funds to complete Heritage Park. This is an exciting project. It is something that we started a few years ago. I think one of the best things about this project is the location of it. If you have a child with special needs and you live in Point Pleasant Beach, Bay Head or Mantoloking, you are going to have a park that is within five minutes that you can bring your child to and be able to utilize and it is going to be in our town for everybody to use. I think that is the most exciting part about this whole project coming together. Yes, we are bonding for some money but there is also a \$100,000.00 donation from Investor's Bank and part of the project is eligible for Green Acres funding. So although it seems like a lot right now, there is additional funding that will help pay for this. Tonight we will introduce the bond ordinance and then there will be the second reading and once adopted we will be able to go out for bids. We are hopeful that there will be shovels in the ground by the Fall.

Also, I cannot tell you how excited I am to see two new officers being sworn in tonight. It is so exciting knowing that my son has aspirations to be a Police Officer and seeing these two young men, it is just awesome. They will be a great addition to our town.

And going back to Mike Kralovich and his crew, one of the things that I have been thinking about lately is how much pride our Police force, our workers and all our town employees take in being a resident of this town and helping make this town a better place. It is amazing how everybody comes together to make Point Pleasant so special. If you are not part of it, you really don't know it. But we know how special our town is and it is nice to have our wonderful employees of this town."

Council Member DePaola stated the following: "First of all I would like to congratulate our two newest members of our Police Department. In today's day and age when being a Police Officer is a really difficult job, you never know what you are going to run into. We had a bomb threat in Seaside this last year, we had a home bomb terrorist here in the Borough. With the help of our Police Department they were able to safely arrest the individual and get them out of our town. Our Police Department works hard every single day doing things that none of us know about and by their actions and their words they keep us all safe. Recently one of our residents sent a thank you letter to our Police Department specifically thanking Officer Wells and Officer Capoano and the rest of our Police Department because they had an issue of unlawful dumping of materials of a tenant who was vacating the premises and just left their things on private property. The Police Department did not just only go and investigate, they followed through and found the people who dumped illegally and had the premises cleaned up and everything cleared away and if it wasn't for their tenaciousness in going back to the scene over and over again to try to determine who was doing that, they never would have found these people. So kudos to them for

improving our quality of life here in the Borough every single day. It makes it a better place for all of us. So thank you again Chief Larsen and your staff.

Also for our kids who are interested in some day having a career in law enforcement, our Police Camp started again this week. That goes on for two weeks at no cost to the parents. For two weeks they get exposed to what it is like to be an officer and forensic science. At the end of the two weeks there is a graduation ceremony which is on the 28<sup>th</sup> of July. So thank you again Chief for you and your officers going out there and putting together a great program for our kids, we really appreciate it.

Finally, as Bill spoke about Sheri who is our new head of the Recreation Department, she has asked us for approval to submit a grant application to the Ocean County Senior Services. What this grant would do if we are fortunate enough to be able to secure the grant money, is to expand our senior program. Right now our senior program meets two days a week at St. Martha's Church. It is the Borough's program but since we do not have a location for the program, we rent space from the church. They are gracious enough to provide us with their cafeteria, restrooms and facilities for our seniors. But right now the program is only 2 days a week. If we can obtain grant monies, we can expand the program to maybe 3 to 4 days a week. Senior services is something that our town has unfortunately been lacking in. So hopefully with the submission of this grant application we hope to secure more funding for it. And all the programs that are done through our senior center are free to the seniors. We like to say that Point Pleasant is the kind of town where you may come here as a young adult to start a family and it is also the kind of place where we like to be able to remain in our homes throughout our lives. Programs like this help enable our seniors to stay here in town and get the services that they need."

**Council President Wisniewski stated the following:** "I would like to echo Councilman Borowsky's comments on the beaches. I went to a Fourth of July party on the Richards Road beach and you couldn't fit another person there it was so used. The whole neighborhood appreciated the effort that our DPW puts into making our public beaches look so nice.

I would also like to thank the police officers. Congratulations to them and hopefully they will continue the great work that our police force does.

You will see on the agenda that we will be finalizing the approval of the annual audit. We have talked about this a lot. It is a good audit and we have 3 things that needed to be worked on and we have already begun to correct those things. This audit is down from probably about a list of 30 when most of us started on council. We have made great strides and it is a real testament to our administration and the hard work they do with the Finance Department."
