**STATEMENT BY MAYOR SABOSIK**: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 13, 2017 edition of *The Ocean Star* and the January 19, 2017 edition of *The Asbury Park Press*.

## A. WORKSHOP

#### 1. Committee Reports

**Council Member Snyder stated the following:** "First I would like to wish everybody a happy holiday and a safe and prosperous New Year. Second, I would like to give a big thanks to our Recreation Department, Chamber of Commerce and DPW. Everybody worked together to put forth a wonderful tree lighting and market. We've received only positive and good feedback on it. I know it was a tremendous effort and everybody worked together and it was fantastic. Thank you, Kayla, for writing a beautiful piece in the Ocean Star. So, thank you to everybody and we hope that will be the first of many more years for that event.

The Environmental Commission met last night. When you are done with your Christmas trees, do not just throw them out. DPW is coordinating with the Environmental Commission and they are going to pick them up. There will be flyers going out shortly. The used Christmas trees will be used for Slade Dale so we are very excited about this. This is phase one on the Slade Dale project.

Finally, we are excited to announce that we are working with representatives with the Greater Mercer Transportation Authority and our Mayor signed a letter of endorsement for the Safe Streets Safe Passages to Schools Initiatives. This is the first step in applying for certification on behalf of the Borough for those initiatives. If you recall, we previously applied for this with grants and never got anywhere. But this letter is hopefully the first step in getting some grant money and receiving Bronze certification. The next level will be Silver and then Gold. That ducktails with the Environmental Commission's efforts to obtain Sustainable Jersey Certification for the Borough. Again, those are three levels of Bronze, Silver and Gold and we are in the process of achieving Bronze certification on that."

**Council Member Furmato stated the following:** "We have 17 snow plows. We have had two events so far and it looks like what we have been doing is salting so everything looks good. If you check the weather, the next 10 days there is nothing going on, so hopefully the rest of winter will be like that.

There is no more paving until the Spring. We have a few roads that we didn't finish from last year. They will be done in the early Spring of next year.

Section 4 of leaf collection was finished today. They will be returning to Sections 3, 2 and 1 and that will all be done by April.

Final testing for the DPW generator will be done next week. The funding for this was done by FEMA. It was \$262,000.00 for 3 generators.

Memorial Drive water tank is being painted and should be done by the end of the week.

Happy Holidays to everyone."

Council Member DePaola stated the following: "I would like to echo Councilwoman Snyder's comments about the tree lighting ceremony. It was a wonderful event. More families showed up than anticipated. It was a great event coordinated between the Chamber of Commerce and the town. Without the employees of DPW and Recreation Department we could have never done this. Thank you to the Police Department for patrolling and having the explorers on this as well. It was a fabulous event. Tonight the PBA and Community Watch Organization is over in the police department wrapping gifts for the needy. The response to the toy drive and the clothing drive for families in need, especially for the families at Dottie's House was great. There are currently 17 moms with their children at Dottie's House. It was a big undertaking to collect enough clothing for all the children and toiletries, hats, gloves and scarfs for the mom's. So with the help of the community here in Point Pleasant Borough and the generosity of the local businesses and the PBA we were able to secure funding for all of those gifts. We received so many donations and we also have a number of families in need in the Borough that would otherwise not be able to provide Christmas for their families if it wasn't for the help of the Community Watch and the PBA. So thank you to the generosity of the citizens of Point Pleasant Borough, business owners, the PBA and the Community Watch volunteers. It is a huge effort. If you see how many toys and clothing were collected, it is unbelievable the generosity of people. Especially nowadays when so many families are hard hit with the way the economy has been the last number of years. Thank you very much to all that have been a part of this.

Dottie's House representatives will be here Thursday morning at 10am to meet with PBA representatives and the volunteers to thank them for their generosity and to pick up all the gifts to bring to Dottie's House to surprise all of the families. Happy Holidays and Happy New Year."

**Council President Wisniewski stated the following:** "This Saturday and Sunday we had Santa Claus at the Bennett Cabin and 719 people attended the event. An extra special thank you to this year's Santa. I hope our Administrator, Frank Pannucci will give him that message. Santa bore a striking resemblance to our Administrator.

I would also like to thank the DPW and the Police who helped over at the tree lighting. It was just a special event.

As far as Finance, we are waiting on a few final details. Once we get that we can start scheduling meetings with Department Heads.

A final thank you to the DPW for awesome leaf pickups. Thank you guys, you did a fabulous job. Happy Holidays to everybody."

**Mayor Sabosik stated the following:** "First I want to wish everybody Happy Holidays and a Merry Christmas. I think that was shown with some of the events this town has had in the last couple weeks. We had the largest attendance of people and we had the greatest outpouring of positivity that I have seen in many years. A large part of that is due to the people who always sit in the back of this room. The Police Department and DPW. They are the unsung heroes. Tonight, we are going to promote one of the people in DPW. This individual goes above and beyond.
