Mayor Sabosik stated the following: "As Councilman Wisniewski just alluded to, it is a little bit more than just an hour a week public service. I am glad to point out today that we have some former Council people in the audience. Roger Pyrtko, Mitch Remig, and Brian McAlindin. Mayor Martin Konkus is also here in the audience. Our surrounding towns are represented here with Point Pleasant Beach Council President Bob Santinello and his boss, Point Pleasant Beach Mayor Stephen Reid. They are here to observe why Point Pleasant has such quick meetings. Also, our newly elected Assemblyman, Ned Thompson, thank you for being here today."

C. COMMENTS BY MAYOR AND COUNCIL

Council Member Thulen stated the following "Good Afternoon everyone. Thank you for coming and joining us on this beautiful cold day. Congratulations to my fellow Councilmembers Snyder and Wisniewski. I am very happy that the people of Point Pleasant selected them to come back and continue doing a fantastic job. I also want to thank our Fire Department, our Borough Employees, our DPW and everyone who works for the town to make it a better place. Thank you for all your hard work. It makes our job a little easier up here. I hope everyone has a great rest of the year."

Council Member Furmato stated the following: "I want to thank everyone for coming out today. Pam and John, congratulations. Bill, you will be spending a lot of your time with Mr. Mayor. He will call you every day. I also want to thank the DPW. They did a fantastic job with the roads. I know they had a tremendous job with the wind. Hat's off to you guys. Thank you."

Council Member DePaola stated the following: "First off I would like to extend my congratulations to Councilwoman Pam Snyder and Councilman John Wisniewski. They are both true assets to the team here in Point Pleasant Borough. We are very fortunate that the residents of Point Pleasant have re-elected them to office so that we can continue doing the good work that we have started. I would also like to congratulate my fellow Councilman Bill Borowsky for taking on the role of Council President. It is a very difficult job, a very rewarding job and a very time consuming job. But at the end of the day, he stepped up because he is the man for the job this year. I know you will do a great job. It is very well deserved.

We truly appreciate each and every one of you and wish you all a very happy and healthy New Year."

Council Member Snyder stated the following: "First I want to echo everyone's sentiments up here and congratulate my colleagues John Wisniewski and Bill Borowsky for being elected again as Council Member and Council President. I also want to thank everyone who made the effort and came out on this very sunny, bitterly cold day to attend our Reorganization Meeting.

First, I would like to extend my humble gratitude to the voters of Point Pleasant for the opportunity to serve our residents for another three years. Your show of support, trust and confidence is overwhelming. I will diligently strive to be worthy of that support as I work with the Mayor and my colleagues up here on council to continue to improve life in the Borough. Second, I would like to extend my warmest of thanks to my

colleagues up here and to all of our professionals, employees and first responders. Working with you these past few years has been a pleasure and I look forward to working with you over the next three years.

There is a wonderful book that was recently made into a movie, it is aptly called Wonder. Some of you may have heard of it. If you have not yet read this book I do highly recommend it to you. In that book, the main character Augie has a teacher who writes a monthly precept on the board. One of these precepts is from an ancient Egyptian tomb inscription that reads, "Your deeds are your monuments." This quote is especially fitting for the people who make our Borough a community. During my tenure on Council I have witnessed our employees and residents not only come up with some fantastic ideas to improve our Borough but they have presented those ideas to Council, our Commissions and Boards and they have worked hard to implement those ideas. I am not going to name those persons or groups because undoubtedly I would inadvertently omit someone. Even if I took the next two or three hours to mention them by name. But suffice it to say, that it has been an absolute pleasure seeing people break out of their shells and I am encouraged by our youth who are enthusiastic, concerned citizens. I have also witnessed our First Aid, Fire Departments, employees, residents and businesses come together to help local families who have suffered a loss or temporary setback. As you look around and see our paved roads, our new sidewalks, our online recreation registration system, the improved parks and beaches, increased police presence and the addition of our K-9 Unit. You will see the tangible evidence of the hard work that my colleagues up here and the Mayor have put in these last few years. Working together as a team and with the support of our employees and professionals, I have no doubt that these improvements are just the beginning. Changes have not happened and will not happen overnight. But they are occurring and I am privileged and honored to be a catalyst in the direction that our Borough is continuing towards.

Third, I would be horribly remiss if I did not take the opportunity to thank my colleagues at my law firm for their support and understanding as I continue to serve on Council.

Fourth, Most importantly I would like to thank my family. I could not serve the Borough Residents if it wasn't for them. They have selflessly given up their time with me for the betterment of the Borough. Each time I look at my children, I see our Borough and our world's future and hope and I am instilled with a fervor to make our community a place where all families and all residents want to call home. And to ensure that the future that we give them is worthy of both their innocence and their optimism.

As I conclude my remarks and I suspect I went way over my time limit, I would like to leave you with words of wisdom penned by a 14 year old girl who faced atrocities most of us cannot even imagine. That girl was Anne Frank. In her diary she wrote how wonderful it is that nobody need wait a single moment before starting to improve the world. I therefore challenge every single person in this room to take those words to heart and to take that first step to improve themselves, their community and in turn the world."

Council Member Wisniewski stated the following: "Thank you Mr. Mayor for making me go after that. I would like to thank the Borough residents, the Borough employees, our volunteers, my colleagues on Council for the work that we have done over the past few years, my family for putting up with randomly walking out of the house because of an emergency meeting or something we have to talk about over at Borough Hall. The hour or two a week that the Mayor and Brian McAlindin promised me years ago that really is about 30. But it has been worth it and I appreciate the support and I hope I can continue to do good work.

I want to say thank you to the DPW for the great work they have done. They did a great job. All the roads seem to be in pretty good shape considering the amount of snowfall that we got this past weekend.

Finally, I would like to say congratulations to my colleague Councilman Borowsky, or should I say Council President Borowsky. Don't let that title go to your head. A couple suggestions, make sure you provide the Mayor with a time to call because he will call every day at that prescribed time.

Also congratulations to little Bill Borowsky. I saw on twitter about the wrestling championship for the team and that is awesome.

Thank you again everybody for coming out."

Council President Borowsky stated the following: "I am a man of few words just so everybody knows. I would also like to thank everybody for coming out today. I want to say congratulations to Councilman Wisniewski and Councilwoman Snyder and all the appointments today, I look forward to working with you in 2018. I would like to say thank you to all our Borough employees. I would like to say thank you to all of our professionals, our volunteers and my colleagues up here. Everyone that makes Point Pleasant the best town in the country to live in. I am looking forward to a good 2018 and I would like to say thank you to my family. My granddaughter is here today with my daughter and my son just walked in. I have to just say one thing; you guys know I am a wrestling guy and I have been a wrestling guy for a long time. I just want to give a shout out to our high school wrestling team. They are currently ranked 5th in the Shore, it is the highest they have been in 30 years. We are ranked as high as 22nd in the State. We have 4 wrestlers that were acknowledged in some publications as the best in their weight class. It is an extremely talented team and I only mentioned this because they worked hard the past 10 years to get what they have achieved and what they are in the process of achieving and that is something that I liken to everyone up here. Thank you to all the Borough employees and volunteers who work extremely hard to make Point Pleasant such a great place to live. And I would also like to say thank you to the residents for having confidence in John, Pam and myself and our entire team up here."

Mayor Sabosik stated the following: "First off I would like to thank the residents of Point Pleasant for having faith in this team of individuals protecting their investments, their homes and their families. When people move to a town, they want the town to provide services to meet all of their demands, wishes and goals. To do that is impossible. But to do the majority of that is possible. This team has met everybody's request within the best of all of our abilities. These requests create positivity in the town and brings life into a town. It takes dedication, hard work and wisdom to create a positivity culture in a town. Where stability of taxes is an importance for the long term. And at the same time creating programs for all generations including our seniors. Having respect for our town employees and letting their creativity and hard work enhance the well-being of our town.

We had more events for families to enjoy and prosper and talk to neighbors during movie nights. Our volunteers who spend thousands of hours getting trained. Our Firemen in the back, our First Aid, OEM, our CERT Team, and our Police Department rated one of the best. Speaking of our Police Department, I am proud to announce that we have a four-legged new addition called Juno who has joined the Police Department. If you went to the beaches this summer, you saw that the chain link fences were torn down. In its place were roses, bushes, chairs and umbrellas to get everyone to come and share what a small town should be and could be. A place to gather and enjoy. Haunts in the Park in October was the best it has ever been because of our employees, DPW workers and our Recreation workers. Anybody who came to the Christmas celebration saw an increased market place with restaurants and rides. Some people said Hallmark has arrived in the town of

Point Pleasant. All of this leads to positivity in town. And this positivity goes to our Boards. Our volunteerism on Boards is at its highest level.
