Council Member Wisniewski stated the following: "Earth Day is coming up and the Bennett Cabin will be hosting the Historical Society and they will be selling community stuff from over the years. Make sure you stop by the Bennett Cabin for that sale if you are around."

Council Member DePaola stated the following: "On Earth Day the Community Watch will be there from 12pm to 4pm. The Community Watch will also be having their monthly meeting on Monday night at 7:00pm so if anybody is interested please come. Also the Community Watch is going to have a fundraiser in June. It is going to be a paint party. We will have more information on that coming up soon."

Council Member Snyder stated the following: "I am just going to say ditto to what Councilman Wisniewski said and remind everyone that we will be passing out tree seedlings on Earth Day. So come on out on Saturday. If it rains, it will be Sunday."

Council Member Furmato stated the following: "Christine Court is moving along nicely. It will probably be a couple weeks until it is completed. Also Bay Avenue looks really good. The paving is done. It looks like the only thing left is landscaping and it will be complete.

Mayor Sabosik re-opened the meeting to the public

<u>John Mogel</u>: 1600 Center Street – Stated that during the last storm the storm sewers backed up to above street level. Also mentioned that in the spring of 2013 the council approved installation of reverse flow valves. Asked what ever happened in that time.

<u>Mayor Sabosik</u> called upon the Borough Engineer, John LeCompte and Roads Supervisor, Jude Walker to respond.

<u>John LeCompte</u> stated that he would have to check into the situation but that 14 valves were installed. The water was so high during the last storm that it went on top of the bulkheads and the water was coming over.

<u>Mayor Sabosik</u> stated that the newspapers read that there were floods in sections of NJ that never get water. Explained that the tide flex valves have been an important program in this town. We started installing them 3 or 4 years ago. Stated that last year we received money for a grant that helped us continue installing them. Clarified that we started the program years ago to help stop the flooding. This program is a priority and about 85 or 90% of the town have these now.

<u>Mr. Pannucci</u> stated that for the past few years the tide flex valves have done a very good job but when you have a storm like the one we had yesterday, Mother Nature is going to have her way.

<u>Mayor Sabosik</u> requested that our Borough Engineer speak with Mr. Mogel after the meeting to find out where exactly this was and look into what happened with the drain.

<u>Dennis Vitkauskis</u>: 2117 Foster Road – Stated that there was water coming up on Princeton Avenue. Also asked why there was a second public session.

<u>Mayor Sabosik</u> answered that it was because a couple people told him they wanted to stand to speak the first time.
