### B. WORKSHOP

1. Committee Reports

Council Member Snyder stated the following: "Earth Day was two weeks ago, and it was an astounding success. I would like to thank our Environmental Commission, especially Chris Constantino who is the Chair of that Commission. He put together a wonderful program and day. We had some new vendor's there and new non-profit organizations who were on hand to give out information on ways to keep our Earth healthy. We also passed out approximately 400 tree seedlings to those in attendance. They were given out for free courtesy of the State of New Jersey Commission of Forestry.

The next big event coming up will be Summerfest in June."

**Council Member Furmato stated the following:** "The boat ramp on Bay Avenue is done and it looks great. It is all ready for the summer.

Also, Christine Court, the sidewalks on the Beaver Dam Road side are all done and all the curbing is done all around Christine Court. All they have left is the paving. That road is going to be a complete reconstruction. Also, tonight Number 7 on the Consent Agenda we will be authorizing RVV for design and engineering of roads in town that will be paved this year."

**Council Member Wisniewski stated the following:** "We are just waiting on our annual audit. We are anxiously waiting and hoping this will be our first audit with zero comments. I spoke to our auditor and he said it is looking good. I will let everyone know as soon as I hear anything."

**Council Member Thulen stated the following:** "I have been working with the Zoning Board and their attorney and we are making changes to our sidewalks ordinance. Hopefully we will have that back by the end of the week and we can have a committee meeting next week."

Council Member DePaola stated the following: "First off I would like to recognize some of our police officers on jobs well done. Officer Rossi and Officer Nickerson were thanked by a senior citizen whose husband is elderly and had a medical emergency. The door was locked when they got there but they were able to find a way in and give medical assistance prior to the ambulance getting to the scene. Also, we received a thank you from one of the dads from Ocean Road School. At their preschool track and field event, Officer Kevin Aurin was there and one of the dads wanted to thank him for not only being there for security purposes but also for giving the children much needed attention. The children really appreciated his appearance there as well as the parents and the teachers. So, I just want to thank Officer Aurin for his outstanding job that day.

I would also like to announce that the 15<sup>th</sup> annual Police Youth Summer Camp will be held this summer. The Point Pleasant Police Department will be sponsoring this summer camp. It is open to all Point Pleasant Borough residents ages 11-13. The camp will run for 2 weeks. Week one will start on July 23<sup>rd</sup> and end July 27<sup>th</sup>. Week two will start July 30<sup>th</sup> and end August 3<sup>rd</sup>. Campers who apply will have to be able to attend the camp for the full two weeks and must be able to perform rigorous physical activities. Campers will have to adhere to a strict disciplinary policy and time schedule. Due to great success of this camp in the past the number of campers is very limited. The Point Pleasant Police Department will decide on who will attend. Anyone who is not selected for this year's camp may apply for future camps. Applications are available at the Point Pleasant Police Headquarters. They will be available as of May 3<sup>rd</sup>. All applications may be returned no later than May 13<sup>th</sup>. All this information is available on the Point Pleasant Police Department's Facebook page. The Police Department is going to be conducting a public service event in the front parking lot of the police department. On May 26th from 9am to noon Officer Gunnell will be assisting with the proper installation of child seats. That has always been a huge success here in the Borough. Officer Gunnell is certified in this and he will be available. Also, Officer MacIver will be assisting seniors that day in the Car Fit Program for older drivers. The Car Fit Program began in combination with the AAA, the American Occupational Therapy Associates Incorporated and AARP. The aim is to make sure that older adults have the opportunity to learn and check how well their personal vehicle fits them. According to the Carfit.org website older drivers are more often the safest drivers. They are more likely to wear their seatbelts and less likely to speed or drink and drive. However, older drivers are more likely to be killed if a crash does occur due to the fragility of their aging bodies. This driver safety program is meant to improve safety by addressing cognitive abilities and skills and by making sure their car is a proper fit for them. Officer MacIver who is certified in Car Fit will be here from 9am to noon that day as well.

Lastly, the Community Watch Organization will be holding a paint party fundraiser to help raise funds for scholarships and for National Night Out which is held the first week of August. The paint party will be held on June 28<sup>th</sup> and more information will be forthcoming."

Council President Borowsky stated the following: "Our Point Pleasant Recreation summer schedule for 2018 is all set. Signups for borough residents is May 15<sup>th</sup> and for non-borough residents is May 27<sup>th</sup>. Some of the new programs added for this summer are: lacrosse camp, reading club and a training for a 5K for adults. There is a new before care program for children ages 5-12 for full time campers to allow parents to drop their children off an hour earlier if they need to. Also, there is something new this year for the children attending the full-time summer camp. Parents no longer need to make the full payment of \$540 right away. They can now make two payments. One in May and one in June. Our Rec Director is working with our Recreation State Program Instructor on Skateboarding Day on June 21<sup>st</sup>. She will be meeting with him to see what they can come up with to promote skateboarding in the town. They are going to reach out to some of the local businesses that are involved in skateboarding to see if they will come and possibly hand out

some free stickers to the kids and try to get some of the professional skaters in the area to come out and perform.

Lastly, I would like to talk about the upcoming Memorial Day Bike Parade. It will be Sunday, May 27<sup>th</sup>. Lineup begins at 10:30am at Community Park. This is open to children ages 2-12. Children will pick up their number when they get to the parade and do one full lap around Community Park. All children must be supervised by an adult and helmets must be worn by all bike riders. Children can pre-register their bikes ahead of time on our website as well as register on site the day of. All are encouraged to please stay afterwards for the Memorial Day Ceremony. It was a great event last year and we are hoping for an even bigger event this year."

# 2. Report of Mayor

**Mayor Sabosik stated the following:** "I have a letter from the Ocean County Health Department. They are pleased to announce they are conducting a community job fair on May 17<sup>th</sup> from 4pm-7pm. Each of the Health Department divisions will have a representative to answer questions concerning all the work they do. The public is invited to attend. Job seekers are encouraged to inquire about present and future employment opportunities. This event will be held at 175 Sunset Avenue in Toms River and this notice will also be on our Borough website.

Spring has sprung. Point Pleasant is going to have a lot of great events coming up. We previously mentioned Summerfest which is June 1<sup>st</sup> and June 2<sup>nd</sup>. The weather has finally gotten warmer. It is really nice out there so we are going to have a lot of people out walking and talking and bicycling so let's all be very careful out there."

### Mayor Sabosik opened the meeting to the public

<u>Grace Almasi</u>: 2215 Christine Court – Stated that they just got new curbs which are great but questioned the Council about her easement and drainpipe.

<u>John LeCompte</u>: Responded that he believed his office did an evaluation of the storm sewer in that area a year and a half ago and found that there were several issues including a collapsed pipe in one section. In the mean time they have been putting together a game plan and are considering it.

Grace Almasi: Explained that this has been an issue for too many years.

<u>Mayor Sabosik</u>: Asked our Borough Engineer and our Public Works Superintendent to get together and make a proposal to the town Council. Also invited Ms. Almasi to Mayor's Hours which he stated would be Monday, May 14<sup>th</sup> at 5:45pm.

<u>John Mogel</u>: Complained to the Council about the reverse flow valves and flooding.

<u>Mayor Sabosik</u>: Explained that there has been an ongoing installation of the reverse flow valves and reminded him that they told him last month that we have to wait for a grant for these. Stated that we are reacting and trying to fix the problem. Stated that he is not debating that Mr. Mogel has a problem. That is understood and the Mayor and Council are doing their best to attack the problem neighborhood by neighborhood.

John Mogel: Also mentioned that the seam in the road deteriorated after Storm Sandy.

Mr. Furmato: Explained that all the seams in all the roads over in his area deteriorated after Sandy. The whole infrastructure over there was damaged and the storm 3 weeks ago created more problems. The water kept percolating through the storm drains because the bay was so high. Stated that there is very little that we can do about that.
