We have our former Mayor, Martin Konkus. We have former Councilman Mitch Remig, former Councilman Brian McAlindin and we have Councilman Mike Thulen, Sr. from Bricktown. And above all, we have our Assemblyman Ned Thompson here today. He has been in office awhile and he has been doing a great job helping the town of Point Pleasant so I would like a round of applause for him also.

As we gather here today, we can reflect upon the resilience of Point Pleasant Borough. Like the phoenix coming out from the aftermath of Superstorm Sandy, Point Pleasant has shown what makes us different from other towns. How we were able to restore our community's mental and physical well-being by providing essential services and giving our residents the support they need to rebuild their homes and businesses. This took a team effort. Looking back, this Mayor and Council stand before you taking great pride in the accomplishments that have been completed. Point Pleasant Borough has been rated the number one town to raise a family in Ocean County. We are rated in the top 30 towns in safety in the whole State. While accomplishing this, this Mayor and Council has also completed a bond rating improvement for our residents and a record number of capital improvements. We want to keep rebuilding our roads, increasing our senior services and continue to upgrade our social events for all of our citizens to enjoy. We use the team approach. Together everyone achieves more to accomplish everything that has been done and what will be done. We acknowledge all our volunteers and the tremendous work that they do. We take this philosophy to heart as we begin to plan the celebration of Point Pleasant Borough's centennial in 2020. In closing, I thank all of you here today and all the residents of Point Pleasant and their support and reelecting myself and the rest of council up here. But I really want to thank my family who have put up with me being late to parties and missing meals and understanding my duty here and my measures to make this Borough the best we can all make it. Above all, I want to thank my wife. Through her love, devotion and

acceptance of our busy life, she is undoubtedly my strongest supporter. God bless all of you and God bless America."
