Council Member Furmato stated the following: "A little update on Bridge Avenue and Beaver Dam, there a few more sidewalks and curbing that needs to be done. The asphalt plans are not available yet, but everything looks good for starting in April. Bridge Avenue is going to be done during the evening hours."

Council Member Snyder stated the following: "For those of you who may not know, we actually have a volunteer fire department here in the Borough. It is actually a very robust volunteer fire department and we are adding three new members. I just wanted to thank them for volunteering their time and want to encourage anyone else who would like to do so to go and be a volunteer."

Council Member Wisniewski stated the following: "Real quick on the budget, everyone on Council should have received their budget books. We are going to start reviewing and if you have any questions please let us know. We are going to coordinate one more finance meeting depending on if there are any specific departments who want to have a meeting with us as a group."

Council Member Borowsky stated the following: "We had a Rec Committee meeting on February 27, 2019. Some of the things we discussed were our seniors. There are a lot of great opportunities for our seniors at the Senior Beehive. Some activities going on include birthday bingo where they had 45 participants. Exercise is offered three times a week. AARP offers free tax preparation from February to April. There is a casino bus trip on March 27th. They are having a St. Patrick's Day party on March 14th at 11:30am. I encourage Mayor and Council to go if they can. They already have 150 people signed up. The Easter Egg Hunt will be on April 13th at 11am at Community Park and there will be 5,000 eggs. We are still looking for some golden egg sponsors if anyone is interested. They already have 100 kids signed up to hide the eggs. This year at the Memorial Day Ceremony, the essay contest of "Why We Celebrate Memorial Day" is going to be opened up to our school kids, so that will be exciting. Permits are coming in for Riverfront Park already which is great. They are going to redo the tables in the pavilion to be removable in case anyone wants to be married under it. It is going to be nice when it is done.

I would like to say congratulations to Point Pleasant Borough Class of 2014 Wrester Ryan Budzek this past weekend down in Virginia he won a national title at 149 pounds. And I am going to go on record and say that no one will ever win another national record. It is that hard. He is the first one in 50 years. It is absolutely amazing. There were only two kids invited. I would love to see Mayor and Council acknowledge him at one of our upcoming meetings."

Council President Thulen stated the following: "Three things I have tonight. One, we have an ordinance on for introduction tonight for our sump pumps. As everybody knows, we have had a very wet 2018 here in NJ and we will probably have an issue for a while. But we thought it would be a good idea to enforce sump pump regulations in our town. Also, I wanted to let everyone know that the committee was looking into changing the software program that we use in the Building Department. The current one we are using is outdated and is no longer being serviced. We have been looking to test out another software program called SDL that our neighboring towns are using, and it seems to be getting glowing recommendations. The beauty of this software is that it is good for the residents to use. It comes with APPs and desktop that they can use to get information about our town. We can implement this over time, for instance we have the

introduction for the mapping of our water system right now. So when that information gets back to us and we put it into the program it is accessible not only to employees but to the public."

2. Report of Mayor

Mayor Sabosik stated the following: "I have a short report tonight because I have been out of town. I took my lovely wife on a well-deserved vacation as you can see she has a great suntan. It was a great vacation but now I am back to work.
