<u>STATEMENT BY MAYOR SABOSIK</u>: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 11, 2019 edition of *The Ocean Star* and *The Asbury Park Press*.

A. WORKSHOP

1. Committee Reports

Council Member Furmato stated the following: "As you can see, Bridge Avenue looks really good. Beaver Dam Road is in the works and started today. This year, it looks like we have eight roads that are in our budget tonight. We also got a NJDOT grant that we got from the State for \$396,000.00."

Council Member Snyder stated the following: "First as you may note on the agenda we have several personnel appointments that are going to happen tonight. I am pleased to say that we have some more volunteers for our Fire Department and we also have some volunteers for our office of Emergency Management. We are also going to be hiring some temporary Dog Census Takers. Yes, we do go around and make sure that all dogs are registered. On the Environmental Commission side, the Slade Dale project is progressing very nicely. The volunteer events scheduled for this past Saturday was postponed due to the rain. However, the folks from the American Littoral Society have already started the project and they may actually have it completed without the need for more volunteers. So stay posted and we will let you know if they need any additional help. Last but not least, just as a reminder, Earth Day is this Saturday with the rain date of Sunday. Just in advance, I would like to thank everyone who helps make this event so successful. Our Environmental Commission worked very hard to make this an enjoyable event. They coordinated with our Police Chief and Lt. Downs. Our K-9 Officer, Kaya is going to be present at the entire Earth Day event this year, so we are going to be well protected. Also our DPW has been doing great with coordinating with the Environmental Commission as to garbage and other things behind the scenes that no one ever sees. That is the magic of our Police Department and our DPW Department. They do all of these things behind the scenes and nobody ever notices and that makes for a very smooth and successful event."

Council Member DePaola stated the following: "First I would like to announce that applications for the Police Youth Summer Camp will be available on May 1st in the dispatch area of our Police Department so anyone interested in signing up their middle school aged child is encouraged to get an application sooner rather than later because unfortunately we always have more children than spots. Applications become

available on May 1st. I must say that my son went through the program when he was in middle school and he loved it. It was a great, great camp for the kids. Teaches them a lot of responsibility. Helps them understand the work of a Police Officer. They get to take a lot of trips and it is all free. We are very fortunate to have sponsors that make this available to our children. If you can take advantage of it, please try and do that for your kids. Also the Community Watch Organization will be meeting again shortly to start planning another National Night Out event which will be held in August."

Council President Thulen stated the following: "I do not have much on the Land Use Committee today however I did want to say thank you to our staff of the Borough of Point Pleasant, especially our Recreation Department for the Easter Egg Hunt last week. They did a fantastic job."

2. Report of Mayor

Mayor Sabosik stated the following: "I too would like to make a comment on the Easter Egg Hunt. As the paper so eloquently stated, it takes hours to set it up and minutes for kids to enjoy it. That is what our town is all about. Giving back to the community and having events such as this.

If you look back a couple years ago, there was an idea from State government that we should do electronic transmission of all information. That we should not use local newspapers as a way for public information or comment. As you know, this Mayor and Council did not think that was a good idea and we still think it is not a good idea. The traditional method of communication is vital to our town. Weekly newspapers reach almost 80% of the towns that they commit to and above all they give an excellence of news reporting to keep people informed of the latest development as well as different topics. I would like to commend Kayla Marsh, she received a State award for articles regarding education by the NJ Press Association. So once again, the power of local newspaper has done a great job at hiring the best of the best."
