Mayor Sabosik, Council Member Furmato and Chief Larsen presented the Proclamations to Sergeant McNally and Officer Rossi.

B. WORKSHOP

1. Committee Reports

Council Member Furmato stated the following: "Friday night was the Borough Centennial Kick-off. It was a fantastic evening and thanks should go to our Borough Administrator, Frank Pannucci; Director of Recreation, Sheri Silversmith; the Point Pleasant Chamber of Commerce, our DPW and Police Department."

Council Member DePaola stated the following: "Congratulations again to Sergeant McNally and Officer Rossi for a job well done. We also received a letter of recognition for Lieutenant Radsniak for his help while on traffic control when the Garden Club was in town. We also received a letter of commendation for Officer Nickerson for helping a young boy who is a Type I diabetic and had lost his insulin kit. Officer Nickerson helped him find his kit and stayed with him until his parents got there. Being the mother of a Type I diabetic, I totally understand what a big relief this was to the family. I would like to offer my thanks and congratulations to Lt. Radsniak and Officer Nickerson for a job well done.

I would like to extend my thanks to Police Chief Larsen and his crew for another wonderful and successful police camp. Graduation was on August 2^{nd} . It was the 16^{th} annual camp and once again we were able to do the entire camp through donations. Thanks again.

On a sadder note I would like to recognize Carol Wolfe. She passed away on Friday. She was one of those people who was always involved in the community and always gave back. She started Dottie's House in 1999 as a housing program for women and children who survived domestic violence. This cause was very important to her and it is a cause the Borough Community Watch Organization took up. Every year they do a fund drive at Christmas for the people staying there and they will continue to do so. I want to extend my deepest condolences to her husband former Assemblymen Dave Wolfe who was our representative here in Point Pleasant Borough and her family."

Council Member Snyder stated the following: "I would like to echo Councilman Furmato's comments on the Centennial Kick-off Celebration. It was the work of a lot of people and I was very impressed by just the Kick-off and can't wait for the 100th Celebration.

We are in the process of interviewing for a Confidential Assistant in Borough Hall. I would also like to echo Councilwoman DiPaola's sentiments on the police camp. It is a tremendous program and I already have had residents reach out to me to get an application for next year's program. Word is getting around, and I think you will have a big waitlist for next year's camp.

I want to make a special mention to our Recreation Department part-time employees who helped out at our Christmas in July Event and the Centennial Kick-off Celebration. They have been doing a tremendous job and our youth employees have been unbelievable. They are dealing with the public who are sometimes irate, and our Rec Department employees handle these situations as well as people who are 20 years their senior.

I presume that Councilman Wisniewski will be giving a more detailed report on this year's audit. I want to congratulate the Finance Department and the Finance Committee on a job well done.

Just a reminder that school is resuming on September 4th and to be on the lookout for children walking and biking to school. We are still spreading the word about pedestrians, bicyclists and drivers obeying the laws. It takes a team effort with everyone working together and I look forward to a safe school year."

Council Member Wisniewski stated the following: "Congratulations to all of the police officers at the camp for a great job. Also thank you Sergeant McNally and Officer Rossi for the great work they did. I also want to thank all of the Borough employees for their work on the Centennial Kick-off. I didn't just receive good reviews, I received "off the charts" reviews on the kick-off.

Two things on the Finance Committee. Through the efforts of Himanshu Shah the Borough CFO, we received a new bond rating of AA3 which means over the next 12 years we will save over \$60,000 a year on our debt service. Just another example of our team here at Borough Hall. As for the audit, this is the second year in a row that we have no comments. What that means is that our professional accounting firm has deemed that we run our Borough finances properly. As an example, I brought in the audit from 2010 and it had so many comments and now we have none. These are things that you don't really see but are tangible improvements and thanks need to go out to Himanshu Shah, Frank Pannucci, Chris Santiago, the tax department and all the employees at Borough Hall."

Council Member Borowsky stated the following: "The 2019 Fall Recreation Schedule is out. Sign-ups for Point Pleasant residents start on September 10th, non-residents on September 17th and will close on September 24th. Haunts in the Park will be on October 25th, and Sheri Silversmith added a "G" rated walk-through from 5-6pm for little children and their parents. There will be no ghouls or things to scare them, which will let them enjoy Haunts without being frightened.

I too would like to say thank you to everyone involved on making the Centennial Kick-off the great event it was. It was a pheromonal night and all the responses have been very positive. It is great to be a part of that. Just to echo what Councilwoman Snyder said, please be careful and drive safely school is opening next week. Also, great job to the Finance Committee on the bond rating."

Council President Thulen stated the following: "I want to echo all the council members before me, the Centennial Kick-off was an amazing night and I met about a half dozen newer residents to town.

The Land-use Committee had a little issue with the driveway ordinance, some of the language enforcing it needs to be revised. Also, we had a meeting back in May where we talked about signage in the Borough, but unfortunately, I got a little busy. I do plan on attending the next Chamber of Commerce meeting to discuss our sign ordinance and get some of the Chamber's feedback because they are local business owners who will be most affected and hopefully find a little middle ground."

2. Report of Mayor

Mayor Sabosik stated the following: "The end of the summer traffic is very heavy. As soon as the summer is over, after Labor Day, the kids go back to school, so I echo my fellow council members up here. We need to be extra careful watching for kids going back to school especially when the weather is good because a lot of them will be walking and biking.

I too, attended the fireworks event which was great. Chief Larsen you had a double header, first the Rotary Car Show and then the Centennial Kick-off fireworks. Great job to you, DPW, and the Recreation Department. It was a great week to be a part of Point Pleasant. It shows how we are different, it shows how we step forward to give things to our citizens over and above what other towns can and will do.

Switching gears, I am also a member of the Census Committee for Ocean County. They are looking for part-time people who are looking to be a census taker. The pay is \$20.00 per hour and anybody that wishes to have a part-time job can call Borough Hall and Frank Pannucci our Borough Administrator will have the phone number to call the census bureau down in Toms River.

I also attended a Barrier Island Mayor's Association meeting this week to fight FEMA. FEMA is once again coming back trying to raise the rates for our homeowners who have flood insurance. It is totally wrong, and it is a misconception in the highest degree. Out in Kansas they can rebuild where they have tornadoes year after year. This area which has a hurricane maybe every 30 years or so are being punished. This is not the right way to treat American citizens and this is not the right thing to do for the New Jersey coast line. This is totally beyond comprehension for them to try to do this. The Barrier Island Mayor's Association met with our Congressman and he is strongly opposed to these increases because it could be up to 25%. We will do everything in our power to stop this bill from being passed in Congress.

I too, would like to offer my condolences to Carol Wolfe's family and to Councilman Joe Furmato who is related to the Wolfe family. She was a great lady and I was very fortunate to be part of the select few to go to Dottie's House and see the great work they do. Dottie's House has a secret location due to the sensitivity of the wives and children. It is an amazing building, she fought long and hard before it became fashionably to take care of beat up women.

The events we have coming up are Haunts in the Park, the Halloween parade and rumor has it we are going to have an enhanced Christmas show this year. So, everybody stay tuned for the new and exciting programs coming forth from this Mayor and Council. With that my report is done."
