Council Member Furmato stated the following: "I would like to take a moment of silence in honor of all who died on September 11th 18 years ago and all those who have died in 9/11 related illnesses since the attack. Further, I would like to thank all those who have volunteered in their local communities and contributed to the individuals who were lost and injured in the attacks. I also want to honor those who serve us daily to keep America safe. Please stand for a moment of silence."

Mayor Sabosik stated the following: "Councilman Joe Furmato lost his brother in 9/11 and I know that I and the rest of Council continually give our prayers to his family in recognizing that tragedy that befell their family."

Council Member Snyder stated the following: "From an Administration perspective we do have some hires and authorizations to hire on the agenda this evening. The first is confirming the appointment of a Confidential Assistant in our Administration Department and that person is Corrine Hughes. She is a Point Borough resident, very highly qualified and really impressed us and knocked our socks off for this Confidential Assistant position.

We are also looking at some temporary full-time DPW laborers. It is leaf collection season, so we need extra help in the DPW Department for that. And last but not least, we are requesting some authorizations to hire temporary part-time Plumbing Inspector and Building Inspector. As you are driving around you probably see that the construction in the Borough does not stop. People are constantly renovating, they are still lifting, there is still a lot going on. So we do have a need for some temporary part-time inspectors. We also have one person in that department who is leaving, so these hires will help to fill that void."

Council Member DePaola stated the following: "I will keep it short and sweet. You will notice on our consent agenda we have the purchase of a replacement fire truck. Currently the Fire Company has been asking for an additional fire truck to replace one that is being put out of service. We already have the funds set aside for this purchase so we will be purchasing this new pumper truck via the NJ State contract which saves the township a lot of money. That is a positive moving forward. And again, thanking our volunteers, our Police, Fire and First Aid here in the Borough. We are fortunate to have so many diligent first responders. And to all the families who have lost loved ones in 9/11, our hearts go out to you."

Council Member Wisniewski stated the following: "I echo Councilwoman DePaola's remembrance of 9/11 and those we have lost. I remember being in my office building seeing the smoke. It is still fresh in my memory and something I will never forget. I know all of us will never forget. Moving on, I have no report."

Acting Council President Borowsky stated the following: "I don't have a whole lot to report on the Recreation front. The 2019 Fall Recreation program registration opens tomorrow morning for our Point Pleasant residents. Registration for non-residents opens next week on September 17^{th.} Preschool starts this Monday, there are almost 100 students enrolled and the classes are full. Haunts in the Park is Friday, October 25th from 5pm-6pm there will be a walk-through for the little ones with no Ghouls or Goblins to frighten them.

I would also like to express my sincere condolences to the Furmato family and all those who have lost someone in 9/11. Let us never forget."

2. Report of Mayor

Mayor Sabosik stated the following: "I am continually receiving many phone calls regarding the fireworks display that the town had for the first time. I have to thank the Recreation Department and our Town Administrator for putting on a great show. It was a great night for the people of Point Pleasant.

October is coming and each year the town of Point Pleasant partners with Clean Ocean Action Beach Sweeps. Just to give you an idea of the growth of this program in 2015 they had 6,000 volunteers. Last year they had 10,148 volunteers. The amount of refuse that was picked up was quadrupled in that timeframe. This is vital for our future generations to have clean oceans to swim without debris. I hope that we can get a good crowd going in this town again in helping them continue their task of helping future generations.

Back to school day I had a great time riding around looking at the kids. I noticed a significant increase. Everybody was smiling going back. Most of the smiling was by the parents and not so much the kids I did notice that. One thing that occurred on Friday night, Point Pleasant football came back and Point Pleasant football won. It was a great night."
