**<u>STATEMENT BY MAYOR SABOSIK</u>**: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 10, 2020 edition of *The Ocean Star* and *The Asbury Park Press*.

**Mayor Sabosik stated the following:** "Before we go into the Workshop portion of our meeting we have a very important visitor who has returned for a second guest appearance from her triumphant meeting in Trenton. And I told her that I thought she looked a lot better at our meeting because they took her picture too far away. Young lady, will you please take a step forward. We are letting her go first because obviously whenever she speaks here, unfortunately for the parents, the ritual is ice-cream after."

The young lady and her father stood before Council and she stated the following: "Thank you so much for recognizing the importance of seizure safety in our schools. Your support meant a lot to me and the entire epilepsy community. Paul's Law was signed by Governor Murphy last week. Thank you for helping to make that happen and for your attention to this cause."

#### A. WORKSHOP

#### 1. Committee Reports

**Council Member Wisniewski stated the following:** "Budget books have been distributed. It is still in the preliminary state as we have not yet finished our union negotiations for the new contracts for the municipal employees. We are going to start reviewing the budget with the department heads as soon as we can get some meetings on the calendar.

As far as Open Space goes, I got the final statistics from Rich Morris. Over 800 people attended Santa at Bennett Cabin with over 500 children. It was a two day event. I was there on Saturday. As you would expect from Rich, next year's gifts are already purchased and he said they are better than ever. You have to go see it to believe it and Rich is just one of the gems of Point Pleasant Borough."

**Council Member DePaola stated the following:** "I just want to wish everyone a Happy New Year. Most of what I needed to say, I said at the Reorganization Meeting so I do not have a report this evening."

**Council Member Archer stated the following:** "I also do not have a committee report but I do want to say that on Saturday, I went to the NJ League of Municipalities Seminar for new Council Elects. It was very nice. I met a lot of new Council Members from a lot of different cities. They went over the budget process so I was able to learn a little bit about that. I also learned about purchasing, bills and ethics and basically what it entails to run a town. So that was my day on Saturday. I really enjoyed it. I am hoping that with my banking career and my background that I can be helpful on the budget committee."

**Council Member Furmato stated the following:** "I also do not have too much. What I do have is the lobby out there is going to be started at the end of the month. The Mayor will be picking out the colors of the floor. The committee meeting for DPW will be scheduled sometime later this month and then I will have more of a report."

**Council Member Borowsky stated the following:** "I also do not have much to report tonight. I did talk to Sheri today and they did have a lock down drill in unison with our Police Department. They do this twice a year where they go on full lockdown. Everyone has a responsibility. They move the kids to certain areas of the classroom where they are out of sight and safe. Everything gets locked. Everything went off without a hitch. They do this twice a year and they do fire drills once a month.

One thing to report with wrestling, I would like to commend the Borough Panthers Wrestling Team. Friday night they had a huge victory in one of the most exciting wrestling matches I have seen in a long time as Councilman Wisniewski will attest to. It was a huge victory over a heavily favored Lacey wrestling team. It paved the way for their fourth B South title in a row. They have a 27 match conference winning streak. Hats off to these young kids. A lot of them are new in the lineup and they just wrestled their hearts out and came away with a big victory. It was very exciting.

We do have a committee meeting Wednesday night at 6:30pm, so I will have a much more extensive report at the next Council meeting."

**Council President Snyder stated the following:** "As most of the folks on Council have said, I do not have much to report today. The next Zoning Board meeting will be January 22<sup>nd</sup>. There are a couple of items on the agenda. I already reached out to the Environmental Commission to let them know that Councilwoman Charlene Archer will be their new Liaison and they are excited about that and looking forward to working with Charlene."

# 2. Report of Mayor

**Mayor Sabosik stated the following:** "The young lady who was just here proves the point that anybody can change government just by asking. She came in here approximately two months ago for a Seizure Safe School Act. We passed a Resolution asking Trenton to look into this. She went to Trenton and they passed it within six weeks. So to say that Government runs slowly sometimes, not when it is important for kids. It went very quickly, quietly and efficiently.

As the Councilman stated, we will be renovating the front of our lobby. We were able to get a grant to do that. We will be picking various colors this evening and we should be able to get it done in a few months so that it will look good for the 100 year anniversary.

A lot of people have called today asking about my wife. She is doing well. I thank everyone for their calls. She had to get a new knee which is kind of interesting since I am the floor man in the family and she had to get a new knee first. A little levity in that. That is all I have for this evening."
