Mayor Sabosik opened the meeting to the public

<u>Chief Richard Larsen</u>: Point Pleasant Borough Chief of Police – "Mayor, I don't know if the agenda has been revised but I need to implore that the bid for the police cars be re-advertised. You had an open bid process and I heard from one vendor that due to the Covid-19 pandemic he was not able to have his boss sign off on it. He would like the opportunity to bid and I am sure there are others out there. I think we need to get that done as soon as we can."

Mayor Sabosik stated that they will discuss this in Executive Session along with a few other topics.

Seeing no other hands, Mayor Sabosik closed this portion of the meeting.

Mayor Sabosik stated the following: "In closed session we discussed some contracts, some proposals with some town employees which we will reveal to the public at a later date. Council, do you have anything to say about executive session?"

<u>Mr. Dasti</u> responded that he had nothing to add other than we discussed potential contracts in Executive Session.

<u>Mayor Sabosik</u>: "Chief, this is what we would like you to do. We are going to go out for rebid. We are going to vote on it right now. But we would like you to get a hold of Winner Ford. We want to see what two vehicles would be available now to buy them for the simple reason that Chicago Ford plant is still down. This plant is going to be down for a while. We are concerned that the cars won't get to us until December or January. So, if we could get a couple cars from Winner, that might help you in your need for vehicles. So, I will talk to you tomorrow about the Winner Ford proposal and then at the next meeting we could talk about it."

<u>Chief Larsen</u>: "As I discussed with you last week, I have a meeting tomorrow with Winner Ford. They are coming here tomorrow. I sent them the information, but they wanted to come here in person. I am not opposed to that but quite frankly, I have been trying to get this going since January. We just got to get it moving."

<u>Mayor Sabosik</u>: "Chief, we can't look back. Now is not the time. We are going to vote on it tonight. It wasn't our fault that nobody bid on it. So, we are going to add an Authorization to tonight's agenda to re-bid. We will re-advertise for 1 to 6 cars. But in the meantime, your concern is that the vehicles are getting so old that you need something now. I really want you to get a hold of Winner. I talked to their General Manager too. They do have vehicles around that they can retrofit for us."

Chief Larsen: "Right, I will set that up."

Mayor Sabosik: "Exactly. So, we have a plan that we are working on."

<u>Chief Larsen</u>: "Mayor, I fully understand that. I am just frustrated by the fact that I have been trying to get this going for months and months and I just want to get this done."

Mayor Sabosik: "Chief, it wasn't our fault that nobody bid the last time."

Chief Larsen: "Mayor, I am not going to debate this with you."

Antoinette Jones: "I just have a question. Are we rebidding for the Ford and the Chevy? Or just the Ford?"

<u>Mayor Sabosik</u>: "Do both bids. Because I am concerned. The Fords may not come out until January. If they keep that plant closed, then we will have something else. Jerry, you said that the Council has to vote on the re-bid for both bids, is that correct?"

Jerry Dasti: "That is correct."

Mayor Sabosik: "Council, I need a vote to go back out to bid for 1 to 6 police cars."

Jerry Dasti: "I would like to just say one thing and I would like this to be in the minutes. Your Borough Clerk did a tremendous job today with the bidder on the cell antenna leases. I am telling you and I have to tell Toni; it is like herding cats with these people. They ask you incredibly stupid questions and she was great at balancing it and juggling all these people. Now, we all let them know that we didn't know how many bidders there were. Toni was great with keeping everybody to the corner and nobody knew what the other ones were doing. Frankly, I think this will be very good for us on Thursday. But I want to acknowledge that Toni did a tremendous job today."

<u>Mayor Sabosik</u>: "Thank you for bringing that to the attention of Mayor and Council. We deeply appreciate it. And we are very happy that we appropriated you years ago from Freehold. You are truly an asset to the town of Point Pleasant."
