Mayor Sabosik opened the meeting to the public

<u>John Mogel</u>: 1600 Center Street – "I have a couple comments about the recent paving project on Glenwood Avenue and Center Street. At the intersection of Glenwood and Center Street, curbing was installed on three corners and not the fourth. Why would they do that?"

<u>John LeCompte</u>, Borough Engineer: "The curbing was not put on that corner because the existing water patterns drain into the bulkhead. If we put the curb in, the water would flow different and we would have to put in a whole new drainage system. Both sides of the street are going across the road and drain into the bay at that point."

<u>John Mogel</u>: "That is my next point. Why wasn't the curbing extended all the way down? Because it is going to wash out. You are going to have asphalt with no sand and no foundation underneath it. Cars are going to come along and that is going to crumble and you are going to have a bigger problem than you had before."

<u>John LeCompte</u>: "The problem is, we already have a bigger problem at the location you are talking about. We are putting road gravel in that area to help stabilize it. The problem is we have one small drain going into the person's bulkhead and we promised them that there would be no additional drainage there. That is part of the promise I made to that resident. If we put a curb in it would put all the water from that whole portion of the road right through that one drain slot."

John Mogel: "There is no natural drainage there. The only drainage there is going into the lagoon."

<u>John LeCompte</u>: "Right, the one thing we could have done was put a new structure in a pipe but it is not the Borough's bulkhead so the existing drain pattern was not altered."

<u>Jerry Dasti</u>: "Sir, you can be assured that if it doesn't work the way our Engineer indicates it is going to work, then we are going to do something to make it work. Let's just give it time and see what happens."

<u>John Mogel</u>: "Okay. I have been around to various departments and I have been told that if I don't get a satisfactory answer to my questions, to come to the Mayor and Council. Sunshine Harbor is considered a residential area and subject to excessive noise ordinance. What is that?"

<u>Mayor Sabosik</u>: "There is a decibel recording level on the books that if it exceeds, people will get a ticket."

John Mogel: "What is the time period?"

Mayor Sabosik: "I would say 9 or 10."

Mr. Dasti stated it was in the ordinance book and we could look it up.

John Mogel: "For construction noise?"

Mayor Sabosik stated that he believes the noise ordinance is 7am to 7pm.

<u>John Mogel</u>: "Who authorized the start of the construction on this road project at 6:30am?"

Mayor Sabosik: "They should have started at 7am."

<u>John Mogel</u>: "My house was vibrating at 6:30 in the morning. They were starting up a road grater 50 feet from my front door."

Jerry Dasti stated that we will look into this.

Mayor Sabosik asked our Borough Engineer, John LeCompte if the project was completely done and if time sheets were submitted. Mr. LeCompte responded that yes everything was complete and that time sheets were submitted but it just notes hours worked, not exact times.

<u>Mayor Sabosik</u>: "Let us make sure that in the future, our specs call for a 7am start and that they submit signed certified payrolls stating the exact hours."

<u>John LeCompte</u>: "Mr. Mayor, we were very clear to the contractors that construction was not to start until 8am on this project. The police were there the entire time. We have uniformed traffic direction there for the duration of projects."

<u>John Mogel</u>: "When I called the police at 6:30am in the morning, they were not sure. He didn't know what the problem was. I explained to the officer that they were starting this and it was not just a leaf blower or a lawn mower. This was heavy equipment. The officer asked, 'what is the problem?' and I told him that it was 6:30 in the morning. Then when I asked the officer outside what the cut off was for the afternoon, the officer told me 'I don't know, I work midnights."

<u>Frank Pannucci</u>: "It is very possible that you spoke to someone who just didn't know, but in the future Mr. LeCompte will let all the contractors know everything they need to know."

John LeCompte: "Absolutely."

<u>Mayor Sabosik</u>: "Let us communicate to the Police Department what the hours of operation are for all construction projects from here on in. And please give that to the Chief to disperse to all of his personnel."

John Mogel: "That should already be in the ordinance. They all stood here and put their hands on the book and took an oath that they would enforce our ordinances. Two weeks in a row, the first time there were a dozen 10 wheeled dump trucks on Glenwood and I could hear that. The second week, they parked the road grater in front of my house, which is illegal because they are not supposed to leave equipment on the street overnight. They were starting it up at 6:30am. When I approached one of the workers from Earle and told him that he was not supposed to start work until 8am he said that they didn't know that. So, I don't know what the noise ordinance is but those are the events that I have had in the past year. In addition to roofers working until 7:30pm with air guns and compressors. And dumpsters dropped off in the street. Not on private driveways. An empty dumpster just crashing down in the middle of the street at 7:00 in the morning. Delivery trucks coming in with the forklifts on the back. The streets are narrow over there so they park down the streets beeping."

<u>Mayor Sabosik</u>: "Counselor, do me a favor and send a memo out to all of the departments in the town of Point Pleasant with the hours of operation for this type of construction to ensure that all personnel are fully cognizant of what this ordinance states."

<u>Jerry Dasti</u>: "Yes sir. And Mr. Mogel, if you leave your information with me, I will be glad to send you a copy of the memo that I send out to the Departments of the Borough of Point Pleasant and the ordinance so that you have everything in writing."

<u>Council President Snyder</u>: "Jerry, I believe there are two ordinances, one for construction and one for noise so please do both."

Seeing no other hands, Mayor Sabosik closed this portion of the meeting.

If it pleases the Mayor and Council, we need to make a motion to appoint Phillip Miller as Municipal Court Judge effective August 1st and at a salary not in excess to what is being paid to Judge Liguori." **MOTION:** Appoint Philip M.
