### Mayor Sabosik opened the meeting to the public

<u>Cheryl Ciara</u> – 543 Summit Drive: "I spoke to you about a week ago about the dogs on Riverfront Park beach. To my understanding, there was never an ordinance. I have been going there for over 20 years. Now, all of the sudden on the Fourth of July I got kicked off with my Lab. There was no reason why. About 3 days later there was a sign put up that says, 'No Dogs Allowed.' Can you tell me why and explain this to me?"

Mr. Pannucci: "Hi, I am the Administrator, Frank Pannucci. No dogs have been allowed on the beach since the Ordinance from 1967. As a matter of fact, there have been signs on both Riverfront Beach and Maxim Avenue Beach that say no dogs are allowed on the beach. Unfortunately, because of Covid-19 and the influx of people coming to visit and social distancing, we are out there enforcing things that we really haven't had to before. Things now are becoming an issue. Because an influx of people have been swimming on the other side of that pier that our lifeguards can't see, more signage had to go up. Which included dog ordinance signs. Everything that was on one side that people would normally see, had to go up on the other side. Dogs have not been allowed on the beach. Unfortunately, it was probably something an officer saw that he never enforced before."

<u>Cheryl Ciara</u>: "He said he got a phone call and it was from someone who was swimming on the beach, and I got kicked off and they were allowed to stay."

Mr. Pannucci: "Well, if your dogs were asked to move up to the park, then that is acceptable, but we do not have dogs on the beach. It is not something new, but with Covid-19 and enforced social distancing we are just picking up on things that have just never been an issue before."

Cheryl Ciara: "Is there any way to reverse it?"

Mr. Pannucci: "I had a lot of people on Council ask me about it and I talked to our risk manager. The majority of any Shore town do not allow dogs on their beaches when there is people swimming, sunbathing, kayaking, fishing and are there doing recreational activities. For a host of insurance and risk management reasons, that is why there are these ordinances."

<u>Cheryl Ciara</u>: "Okay, well I pulled up two of your ordinances. One says that any crafts going out of that area cannot do it while there are sunbathers on that side. To this day, they are still sunbathing and swimming on that side."

Mr. Pannucci: "There is a specific area for people to bring out kayaks and small crafts. That is why we put up more signs that there is no swimming there because with the influx of people, they have been doing it. There are things that have been going on with Covid-19 that has never been an issue before just because of the influx of people."

<u>Councilwoman Archer</u>: "What I was thinking of suggesting that during this season, no dogs should be allowed there because some people are afraid or allergic or whatever. Off season, September to May, a lot of beaches allow dogs on the beach on the off-season. So, while we are in season, the dogs would not be allowed. That would be a way to handle it."

Mr. Pannucci: "A lot of towns do not allow that because, while you are clearly a responsible dog owner, many are not. Our lifeguards would have to be picking up dog waste and things like that when they go on duty before and after. It is an issue. But to your suggestion Councilwoman, many towns do that in the off season where people, in the off season allow their dogs on. That is something that if the rest of council is interested in, I can certainly look into crafting and possibly changing."

<u>Mayor Sabosik</u>: "Unfortunately, it is an old ordinance. In the 1960's Point Pleasant was a different town. As well as the health code being a lot different in the 1960's. As the town Administrator and the Councilwoman pointed out with the Covid-19, I have never seen so many people using our beaches. In fact, I think Councilman Bill Borowsky will tell us, I think our ticket sales were up 7 to 8 times our normal."

Councilman Borowsky: "We are up to 1,800"

<u>Cheryl Ciara</u>: "Well I heard that to the right of the pier, that is the overflow that we are getting from the beach and they are not from this town."

Mayor Sabosik: "That is possible. I have also been down there a couple times telling people that they can't swim on the right-hand side as you're looking at the beach. But the bottom line here is, we are facing something that we never have before. I have a yellow lab. I know they love the beach. But we have to look after the safety of the swimmers in this situation. I know you are a responsible dog owner. I am too. Most of us up here are responsible dog owners. We pick up after our dogs. Unfortunately, today, some people just don't do it. We have a health problem. We have an insurance problem. So that is why I think the Councilwoman's idea is probably the best scenario. The hottest months, they won't be able to go but in the off months we can maybe craft something to change that. I think that is a good middle of the road."

<u>Council President Snyder</u>: "And if you think about it, our beaches are open a relatively short period of time. It is only June when school lets out till Labor Day."

Mayor Sabosik: "We are going to have to craft an ordinance and it takes two meetings. So, stay tuned."

<u>Councilwoman DePaola</u>: "We have to check with the Joint Insurance Fund who ensures our land and makes sure that they don't foresee any problems."

Cheryl Ciara: "Will there be another sign posted up?"

<u>Mr. Pannucci</u>: "Signage will be a whole different thing later on. What I will do, if it is the pleasure of the Council, is I will craft some type of an ordinance for the off season and then I will bring it to all of you to deliberate on it and possibly vote on it on a future date."

<u>Kathleen Ebert</u> – 1203 Dorsett Dock Road: "During Covid there has been an uptick of complaints from the Complete Streets Group of people speeding. There has been a lot more bikers and pedestrians so there is a concern with the speeding, in particular by the bridges. I have heard through posts that they have reached

out to the Mayor and Frank and I was wondering if there has been a follow-up. Have you reached out to the State or County about possibly doing something about signage?"

Mr. Pannucci: "The Mayor had us call the DOT and we also gave those suggestions to the Legislative Office. As you know, the State and all their departments are either not working at all or only a quarter of them are working so they really haven't said one way or the other what they are doing but we will certainly follow up again."

<u>Mayor Sabosik</u>: "And with Safe Streets, I am sure you have read in the paper that we are continuing our endeavor to put more sidewalks and curbs in especially around the schools."

<u>Kathleen Ebert</u>: "Also, I have another question. School Street, by the football field, does that have any plans for a sidewalk?"

<u>Mayor Sabosik</u>: "That is the Board of Education property, but we can call Vinny Smith, School Superintendent and we can look into that."

<u>Robert Forsyth</u>: "School Street is the Borough, but the actual property is the Board of Education. Anything that embarks a public road, the owner of that property is responsible for the sidewalk or curb."

<u>Kathleen Ebert</u>: "A lot of people complain that there is this gorgeous field and then there is this dirt path that gets muddy in the rain and all the kids walk in the street because of it."

Council President Snyder: "It would be safer after the football games at night to have a sidewalk there."
