<u>STATEMENT BY MAYOR SABOSIK</u>: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 10, 2020 edition of *The Ocean Star* and *The Asbury Park Press*.

A. <u>PRESENTATION</u>

1. Honoring Police Chief Richard Larsen on his Retirement

Mayor Sabosik stated the following: "Tonight we have the distinct honor of honoring our Police Chief who is retiring. He has always showed his dedication to our town, hard work and ability to rise through the ranks to achieve the epitome of his profession. Your love of our town will not be diminished as you enter retirement, but it will be enhanced by knowing you did the best. Your best is hereby being acknowledged by the following entities. The New Jersey State Legislature and the State Senate and the Assembly."

Mayor Sabosik read the Joint Legislation Resolution to Chief Richard Larsen congratulating him on his retirement.

Next, Mayor Sabosik read a letter from Governor Phil Murphy noting Chief Larsen's 34 years of remarkable commitment to the safety, health and well-being of the Borough of Point Pleasant and congratulated him on his well-deserved retirement.

Finally, Mayor Sabosik read a Proclamation from the Mayor's office of Borough of Point Pleasant declaring Saturday, December 5th, 2020, "Chief Richard P. Larsen Day" in the town of Point Pleasant."

Mayor Sabosik continued: "Chief, you have devoted yourself to the well-being of our community. Playing a role in helping Point Pleasant be ranked as one of the safest communities in the State of New Jersey and one of the best places to live in all of Ocean County. I applaud you for your leadership and dedication to our town. This is a plaque from Mayor and Council from the Borough of Point Pleasant. On behalf of the citizens of the Borough of Point Pleasant, the Mayor and the Borough Council would like to thank you, Chief Larsen for your dedication to our community. We would like to congratulate you on your retirement after your distinguished 34-year career in law enforcement as Patrolman, Sergeant, Lieutenant, Captain and Chief. The Borough of Point Pleasant will forever be grateful for all you have given, for all you have

sacrificed through the years for the betterment of our community. Please step forward Chief, to accept these accolades."

Chief Richard Larsen stated the following: "First things first, to the Mayor and all of Council, I have been Chief for six years and the job of a successful Chief needs a couple of things to work. One is a great working relationship with everyone in this room which I feel I have had. The conduit was the Mayor to make that work for me. I appreciate that Mayor. I truly appreciate the support that you gave, not only me but my entire department. I could not have accomplished what I did in my six years as Chief without your support. Councilwoman DePaola, Chair of Public Safety my whole tenure. I appreciate your support and the support from the entire committee. I also would like to thank Jerry for advice over the years. Frank, thank you for your support. Toni, I appreciate your support and your facilitation of different things. I also want to speak to my officers here in the room and to those who couldn't be here tonight. The officers and the civilians who are here supported my mission. And, let's face it, I can be a tough boss. I expect a high bar and all of you know that. And when that bar falls low, I make myself known. Whether it is directly to a patrol officer or through the chain of command. All of you in this room and in the department knew my expectations and you stayed loyal to me. I appreciate that from the bottom of my heart. The people in our town appreciate it.

We have unwavering support from our community here in Point Pleasant. I have gotten a number of phone calls, letters from when I was a Lieutenant through Captain to Chief as to how well all of you collectively treat our citizens or members of the public during your encounters. I have even gotten many compliments from those that we arrest, complimenting on how well you treated them. That is quite frankly the way I carried myself throughout my career. I gave everyone the respect that they deserve and even if they didn't deserve it, I still tried to give them my respect. And I am happy to say that is what I have seen from everyone here and in my entire department as to how the public has been treated.

I go back, reflecting on my career, of course, after 34 ½ years in law enforcement, you not only reflect on your career as a cop but on your whole entire life. Let's face it, I was 24 years old when I was hired here. In August of 1986. That is a long time ago. My oldest is my son, Steven. He was born July 14, 1986. I started here about a month after. He was a month old and now he is married and 34 ½ years old. Time goes by quick. In retrospect I would not have changed a thing. This career is a cardinal career. When I first started, it always was and still is. All of you here in this room as officers and those that aren't here. All of you in my department I feel, are the best of the best.

I look back to when I was a young boy growing up in Brooklyn, New York. I attended Holy Name of Jesus in Park Slope, Brooklyn on Prospect Avenue. When I was in either grades 1 or 2 the whole class was asked to write a paper stating what they wanted to be when they grew up and I wrote a police officer. I had an uncle who was on the NYPD and there was only a seven- or eight-year age difference between us. He worked street crimes and the filtered stories he told me made me as a young boy stayed with me and I never wavered from my decision of being a police officer. I made my dream work through hard work. I had an opportunity to go to another municipality early on, but I chose to stay here in Point Pleasant. I was hired in August 1986 and didn't go to the police academy until February 1987 because I missed the cut-off and in that six months that I was here working I felt an affinity to this municipality. The people here are top notch. The spirit in this community, the caring nature of our governing body and the Borough employees. I have not seen that anywhere I've been or lived. I am proud to say that I am glad I made that decision.

It has been my honor working with all of you. I want to thank all the officers in this room for all your dedication to the residents of this town. Mayor, all of Council, Frank, Toni, and Jerry, again I cannot say enough of the support you have given me as the Chief of Police. Thank you very much!"

1. Final Reading and Public Hearing

Ordinance No. 2020-12 – Amending and Supplementing Chapter 8 of the Borough Code to Provide for New Section 8-9 Entitled "Prohibiting" Short Term Rentals of Residential Dwellings

Mayor Sabosik opened the meeting for Public Hearing on this ordinance.

<u>Rick Barry:</u> 1009 Philadelphia Avenue, stated he prepared a statement regarding his property at 1009 Philadelphia Avenue. He brought documents for all of council.

<u>Mayor Sabosik:</u> Stated that he did receive his phone messages today, but on the advice of Borough Council he was advised not to call him back because this ordinance was on the agenda this evening.

Mr. Barry: Read his prepared statement.

<u>Mayor Sabosik</u>: Replied in the past year the Borough has received numerous complaints regarding residential homes being used for commercial purposes, parties, etc. We are a bedroom community, other towns around us have come up with this same 30-day requirement. We are not preventing you from renting your unit.

<u>Mr. Barry</u>: Responded, I am a mile and half from the beach. No one is going to rent my property for the entire summer. I live on the property; we do not want to have riffraff on our property. He stated that just because other towns are doing it does not mean Point Pleasant Borough has to follow.

<u>Mayor Sabosik</u>: Replied that is not why we are doing it. This year they have received numerous complaints from residents. Unfortunately for you, you have a unique situation because you live on the property. We are proposing a 30-day minimum on all rentals.

Mr. Barry: Replied what you are proposing will kill me.

<u>Mayor Sabosik</u>: Stated we are in the middle of a national health crisis, COVID-19 and we have had numerous complaints from residents last year. We are trying to lockdown this town as much as possible and one of the ways to do it is to have a 30-day minimum on rental properties. The last thing this town needs in people coming from up north, and other states coming in for 4-5 days and then leaving. Our hospitals cannot handle it. This is an ordinance to help the town. Unfortunately for you, and I agree, you have a unique situation which can be looked at separately. I urged Council to pass this ordinance tonight.

Mayor Sabosik opened the meeting to the public.

<u>Lee Nelson</u>: 1117 Old Drift Road: Do you have any comments regarding the recent power issues in the past few weeks. We have had several power outages lasting 30 minutes to several hours.

<u>Mayor Sabosik</u>: Responded he has been on the phone with JCP&L and has gone through three levels of senior executives. They are doing a complete study of power coming into our town. I find it completely unacceptable that 500-600 residents are going without power. Half of them get it back and the other half are out for several hours. We will get to the bottom of this. This Administration will not tolerate second class service from JCP&L.

<u>Council President Snyder</u>: Stated that the Mayor has been very calm with you this evening, a lot calmer than he has been in his discussions with JCP&L.

<u>Mr. Nelson</u>: Thanked Mayor and Council for going "out to bat" for its residents on this. He had a question on a separate issue regarding an article he read on the Point Pleasant Patch. Governor Murphy announced that Point Pleasant Borough received a \$401,400.00 grant for the reconstruction of Burnt Tavern Road, Johnson Avenue, Memorial Drive and Old Drift Road. He asked what are the next steps?

<u>Mr. Pannucci</u>: Replied the NJDOT grants are some of the most sought after grants in the entire State of New Jersey. Specifically, this Mayor and Council over the past four years have been successful in getting \$400,000 - \$800,000 in grants which is more than any other Administration in the past.

<u>John LeCompte</u>: Replied Old Drift Road we have looked at for the past four years. Each year it gets a little higher in priority. There are alignment issues, and drainage issues and we did not want to just do a mill and overlay on it. He walked the entire length of Old Drift Road with Jude Walker and they feel it needs a total reconstruction.

Mr. Dasti: Asked what the timetable was?

Mr. LeCompte: Replied this would be a summer project due to the proximity of the school.

<u>Mr. Nelson</u>: Asked if they would take special consideration to the character of the street. He also stated for the record the article mentioned the Borough has adopted a Complete Streets program and he wanted to commend Kathleen Ebert and the Complete Streets Committee for their work on this.

<u>Council President Snyder</u>: Stated that Mr. LeCompte will be in touch with the residents on the street, specifically if they are paving and need residents not to park on the street.

<u>Dennis Vitkauskis</u>: Stated while riding his bike through town he noticed a lot of streetlights not working. He asked if a Borough employee could go through town doing an inventory of the lights.

Mr. Pannucci: Stated he would look into this.
