Mayor Sabosik opened the meeting to the public.

Richard Barry: 1009 River Avenue – "Before I get started, I wanted to say thank you. I had repairs done on my street by Public Works and they were spectacular. They did an incredible job solving what I thought was an impossible problem. We had flooding there and really benefitted from that work after suffering for a long time. Also, my brother had a problem on Harold Lane, and we made the Mayor and Council aware of it and they worked hard and responded to it. I greatly appreciate your response. I encouraged him to reach out to the Mayor and Council and I knew you would respond. Unfortunately for me, we have a small rental cottage in the back of our property that we have been renting since my mother-in-law died. We reside on the property. We own the property. It is consistent with what other towns have recognized as acceptable for short term rental. Because of where we are situated and because of certain circumstances, like there is not a washer dryer, we are not an attractive property for a 30-day rental. We tried to rent it out using a realtor and we did not get any interest at all."

Mr. Barry went on to explain issues that he has with the 30-day rental.

Mayor Sabosik noted that Mr. Barry was supposed to get some information to Mr. Dasti that had not been received yet for review.

Mr. Dasti stated that they did talk briefly about Mr. Barry's request to consider changing the Air B&B Ordinance to exempt owner occupied and it will be considered.

Mr. Dasti and Mr. Barry further discussed what is considered owner occupied and problems of enforcement.

Mayor Sabosik also stated that they will be considering exemptions to the ordinance. Also asked Mr. Barry to please forward the paperwork that they initially asked to review.

Mr. Barry handed out 7 copies of background for each member of council.

David Wurfel: 1007 Philadelphia Avenue – Stated that he has lived next door to Mr. Barry since 1983 and has never had any complaints between him and his neighbors. Came to the meeting to show support for Mr. Barry.

Linda Shaughnessy: 1011 Philadelphia Avenue – Came to the meeting to show support for Mr. Barry. Stated that her living room window is less than 20 feet from the cottage Mr. Barry rents and she never hears a peep out of anyone. She only knows it is being rented when the light is on. Has never been a problem.

Kevin Ostrander: 609 South Manetta Drive – Wanted clarification on when the Borough has Council Meetings.

Mayor Sabosik responded that in the summer months we have one meeting a month but come Fall it goes back to 2 meetings a month.

Kathleen Lieber: 1203 Dorsett Dock Road – Thanked the Mayor and Council for all the projects and events going on around town. Also mentioned that she had spoken to Frank but wanted to mention it to Mayor and Council that there have been a lot of concerns on Route 88 by the Rita's. There have been a lot of crashes and a lot of close calls and asked for help and more enforcement.

Chief Lokerson: Stated that he has been in contact with the State and the County regarding that unique intersection. Crosswalks and signs were installed. Detailed that it is difficult to install lights there, but they are continuing to look into it.

Council President DePaola: Stated that when they finally got the State to agree to put the crosswalks there, they were hopeful that it would alleviate the problem. Unfortunately, there are a lot of people speeding and we are trying to come up with new ideas. Also noted that the Chief has a lot of enforcement in the area and will continue to have officers in that area.

Kathleen Lieber: Also stated that the home at 2405 Hemlock has been vacant and is becoming overgrown with standing water.

Mr. Pannucci: Stated that he will email the code enforcement officer right away.

Dennis Vitkauskis: 2117 Foster Road – Mentioned to the Council that his power went out again. Asked if the Mayor and Council could talk to the BPU.

Mr. Pannucci: Stated the answer is exactly the same as the last time he brought this up. All the Mayor's on the barrier islands got together at the request of Mayor Sabosik, and they are formulating a multi-town plan to confront JCP&L together instead of separately. Noted that this is still in the works.

Mayor Sabosik: Added that he is questioning their return of investment. Stated that he does not have the numbers yet, but he will get them.

Dennis Vitkauskis: Asked about the new sign at the end of Roberts Place and Bridge Avenue telling pedestrians to use the crosswalk at Beaver Dam Road. Noted that right across the street from Roberts is an opening in the gate to Community Park. Stated that if you want people to use the crosswalk, they should close that entrance to the park to encourage people to walk over to the crosswalk.

Mayor and Council stated that they will look into that.

Seeing no other hands, Mayor Sabosik closed this portion of the meeting.
