## 1. Committee Reports

**Council Member Charlene Archer stated the following:** "First, I know that many of us will be mentioning this, but finally being able to celebrate our 100-year anniversary was a huge success. It was wonderful. I want to thank everyone who was involved and worked on it. DPW, the Chamber of Commerce, Police and Recreation did a great job.

In our Environmental Commission, we did have a resignation. Christopher Constantino has been with the Environmental Commission for quite a while and due to personal reasons, he has stepped down. And now with his retirement, we do need another member. But they are going to have Earth Day. It has been delayed and delayed but we will be having Earth Day. April the 23<sup>rd</sup> is going to be Earth Day. We did the Slade Dale Project a few years back where they put the Christmas trees in the Slade Dale marsh and it is doing exactly what it was supposed to do by building up the marsh. It has been successful, and we are going to continue to do it by collecting Christmas trees again this season and every year. Also, the Environmental Commission has replaced the signs coming into Point Pleasant. Some were missing or damaged and so now, all new signs have been installed. The Point Pleasant Rotary Club donated \$500.00 towards the new signs, so we thank them for that."

**Council Member Valerie Coulson stated the following:** "The Land Use Committee met with our new Code Enforcement Officer, Colleen Malvasio. We are beginning the process of reviewing dated Land Use Ordinances that we could possibly update, improve and streamline some of the permitting processes. We will be reviewing and making these recommendations from now through the Spring."

Council Member William Borowsky stated the following: "I too would like to congratulate our Recreation Department, Public Works, Police Department, Frank, I know you had a big hand in it, on a successful Centennial Celebration. What a great job the other night. That Centennial plus one was absolutely amazing. I am so proud to be from Point Pleasant and be a part of that. I would also like to take a moment to thank some of the sponsors that made it possible. This event went off and did not cost the taxpayers a penny. The sponsors were: Pine Belt and Charlies of Bay Head. All American Ford, Dasti, Murphy and McGuckin Law Firm, CME Associates, Manasquan Bank, Ocean First Bank, Statewide Exterminators, Investor's Bank, Crestpoint Rehab, Dunkin Donuts, Natures Reward, M. E. Sabosik Associates, Northeast Sign and Lighting and Butler's Pharmacy. Thank you to all of those generous businesses. This event took off and didn't cost this town a penny. And, once again, I would like to thank Public Works Buildings and Grounds Department. They are the unsung heroes of this event. Setting this place up and taking it all apart after everyone was gone.

Next, I have Haunts in the Park this Thursday, October 28<sup>th</sup> from 6pm-9pm for the bigger kids. There is a family friendly hour from 5pm to 6pm for the little kids. You can prepurchase tickets at the Rec Center so that you don't have to wait in the long line to get tickets. Sheri is hopeful that it will help things run a little smoother and a little faster than it has in the past. Over 400 tickets have already been presold."

Council President Antoinette DePaola: "First off, tomorrow night, the Point Pleasant Police Department in conjunction with the Community Watch Organization was to sponsor a Trick or Trunk event tomorrow night. However, due to the impending storm, we have moved the event to Thursday along with Haunts in the Park. So, it will be a big night in town. The Trick or Trunk event is mainly for younger children, preschool through fifth grade generally. There will be a costume contest during the evening. So we urge all of our families to come on out Thursday night for a fun evening in the park. I too would like to thank DPW, the Rec Department, Police, Fire, First Aid and all of our volunteers for a wonderful event at the park on Saturday night. It has been a long time due to Covid when we were all able to get together and I saw people at the park Saturday night that I haven't seen in a very long time. So, it was nice to have a safe, outdoor, family friendly event, with lots of free giveaways thanks to our sponsors. And again,

thanks to the hard work of the Borough Employees who helped put this together and keep it going to the enjoyment to all of us. That is why we love living in Point Pleasant.

Lastly, the Police Department did submit a request to the state of New Jersey to look at some traffic calming ideas for the intersection at Northstream Parkway and Route 88 due to some concerns that were brought to our attention. At the last meeting there were residents that stated they felt it could use a little additional help at one end by the ice cream parlor at one end and Pat's Pizza at the other end. There is just so much going on at that intersection. As the Chief explained last time, it is a very difficult intersection because it is not a typical "T" intersection so we will see if the state responds to that request.

I would also like to send my condolences to the Pyrtko family for the loss of Roger. He was a great member of our community. He was always there when we needed him. He did a lot for us for our National Night Out and for our Community Watch. He was always volunteering and always giving back. This truly is a loss, and I would be remiss if I didn't say something."

## 2. Report of Mayor

Mayor Sabosik stated the following: "The last 18 months has been an unprecedented time for our residents through Covid. Through it all, the people on this dais have kept a steady hand for safety, disseminating information and being transparent for the benefit of all of us. We have maintained town services and planned for the emergence of Covid 19, like the events that we had this past weekend. These events have allowed for the socialization of multi-generations. And we will continue with what we are doing this week with Trunk or Treat and Haunts in the Park. We must continue to return to normal interaction. We must continue to have economics in our government. Some of the finer points that this Council and this Administration has done in the town are this: Our home values have gone up dramatically, we have created new recreation facilities, A safety factor with our new Police Chief, Community Policing, installing sidewalks throughout our town, we have paved a record number of roads, and our finances have never been better. Our state audit has come back with no blemish and no problems. Let's talk about finances for a short minute. Sandy came and really destroyed this town many years ago. This administration has been fighting with FEMA and extending our loan not paying the interest because we felt in our hearts that the right thing to be done would be for them to forgive this loan as they have done in other parts of the country. Louisiana, Kansas, anywhere else they have forgiven this money. I am happy to report tonight that I have received a letter from FEMA that our congressional delegation has accomplished it and we are receiving a dispensation of payment for \$3,207,967.00 as well as over \$300,000.00 in interest that we did not pay them because we were in a dispute. So, as you can see, we do many things behind the scenes to ensure that this town gets the just reward and that we are not overcharged by any government agency. So, I want to thank Council for being strong in this regard. I want to thank DPW and the Police for a great weekend that we had, and I look forward to a lot of great events coming up. And rumor has it that Santa Claus will be coming to Point Pleasant again this year."

**Dennis Vitkauskis:** 2117 Foster Road – "I just wanted to say thank you to the Borough Clerk for the "Do Not Knock sticker that came to my house."

**Maria Ritter:** Did not state address – "I was talking with John with the Open Space Advisory Committee that some property amount has become available. It is the old Kennel property and I know that there was some interest, and I just wanted the Council to know that there is a group of us that all live in that neighborhood as well as some fisherman who I have talked to who fully support that and will do whatever we can do to help the council to acquire the land. We would like to start a conversation with you all about this."

**Mayor Sabosik** "Well I am happy to report that we have done more than start a conversation about that because I have always thought that is the perfect place to keep in its natural state. It is a perfect place to teach young people how to fish. Sons, daughters, grandchildren. So I have been in contact with the County. They have Open Space money that far exceeds what we have obviously. So I hope to announce very shortly that we will have a positive end to this story.

**Mr. Pannucci:** Mayor Sabosik and the Council about two weeks ago, directed me to write a letter to the County to the Natural Lands Trust that they fully support them using the Natural Lands Trust money to purchase it for preservation purposes. So now what happens is, the short version is now the County will contact their landowner and do their due diligence and go through whatever that process is. Hopefully, it goes accordingly. It is good that you came because when they do contact us again, I can say that the members came to a public meeting and spoke on the record in support of this."

Maria Ritter: "It is small, but it is beautiful."

Mayor Sabosik: "It is the perfect location in that part of town to continue the tradition of fishing and having a peaceful coexistence there. But the county has informed me that they do have plans to buy it. We just have to talk with the owner and go through the process."

Mayor Sabosik stated on the record that Council Member John Wisniewski just attended the meeting. He was late due to his flight being 4 hours late.

Mr. Wisniewski apologized for his tardiness.

**Britta Forsberg:** "Good evening, Mayor and Council, I am the executive director of Save Barnegat Bay. I am also born and raised in Point Pleasant Borough, so I am very familiar with the property at 720 Mount Place and, our organization as I believe you already know, has been a long-time supporter of the Canal Walk and also a pocket park in that location. I have been in contact with the listing agent and the Ocean County National Lands Trust and this afternoon I got off the phone with Trust for Public Land. There is a lot of public support for this initiative. I just wanted to remind you that we are here, and we are standing beside you, and we will help you in any way as this process moves forward.

**Mayor Sabosik**: "You and I have had many conversations over the years, and you know that this administration believes in Open Space. We want to continue the tradition of what this town has. Which is perfect, quiet locations to just sit in a chair and watch the boats go by. I am very happy to say that the County was very positive and have reacted quickly for us. They do have the money set aside. They did vote on it already."

**Britta Forsberg:** "We appreciate your leadership on this."
