<u>STATEMENT BY MAYOR SABOSIK</u>: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. A. <u>WORKSHOP</u>

1. Committee Reports

Council Member Charlene Archer stated the following: "First, I wanted to congratulate Councilman Bill Borowsky and Councilwoman Toni DePaola on their success on winning the election again and having another three years on our council. I also want to Congratulate Councilwoman Valerie Coulson on winning the election as well. Congratulations!

I am the liaison to the Environmental Commission and they are being very active lately. They are trying to get themselves up and running since covid. They were kind of laying low and now they are getting a lot of things going on. They have 20 planters all along Point Pleasant and they change out the plants every season. So they are continually doing that. They are looking for sponsors. It is \$150.00 for a business to sponsor the planter. The Environmental Commission would also like to make pollinator pocket gardens around the town. They are looking to see if they can find some acceptable spots that can be approved for placement around the town. This will be good for butterflies and bees and such and they are good for surrounding plants.

The Environmental Commission would like to improve the area around Slade Dale. They are beginning to put chips down for the walkways. They are looking to add signage as well. They are also starting up with sustainable New Jersey. They want to try to get a Green Team set up in town.

For Earth Day, the theme will be about replacing trees which they were trying to do prior to covid. They want to replace trees that are native to New Jersey."

Council Member Wisniewski stated the following: "The Open Space Committee are committed to having Santa at the Bennett Cabin. Everything will be inside. They have all their toys and everything is all pretty much set up. The date will be December 11th and December 12th.

As far as the Finance Committee, we are looking to set up a meeting to wrap up the calendar year. We do not have a date for that yet, but I will update everyone as soon as we do."

Council Member Furmato stated the following: "I would like to congratulate Bill, Toni and Val for winning the election. It was a good day for them and for us and for the town of Point Pleasant.

On DPW, we received a grant for the state for Summit Drive reconstruction for \$286,000.00. That will probably be done in the Spring. This year, we are up to about 17 roads that we have repaved and hopefully we will be able to do the same for next year."

Council President Antoinette DePaola: "As you know I am the liaison to Public Safety and as part of my duties with Public Safety and the Police Department I also volunteer with the Community Watch organization and I would just like to let residents know that we will be collecting donations for Dottie's House. For those of you that don't know, it is a residency for victims of domestic violence and their children. Every year we do clothing drive and toy drive for the children their and also a toy drive for the children at Brick Hospital who are there during the holidays. Information for that will be forthcoming. Anyone who wanted to adopt a child has already been given a name and they purchase pajamas and winter clothing and boots, hats, gloves and things like that for the kids. It is just a wonderful experience to be able to give back, so that is another reason why Point Pleasant is such a wonderful place to be.

Before I move on, I would like to thank the residents of Point Pleasant for voting for myself and Bill Borowsky and Valerie Coulson to the Council. We truly find it to be a privilege to work for the residents. It is a wonderful town and we have great Council members up here and a wonderful Mayor. We have wonderful residents and it is truly a joy to be able to serve this wonderful town that we love. I would like to just extend on behalf of all of us a thank you. Happy Thanksgiving to everyone."

Mayor Sabosik stated the following: "I would also like to offer my congratulations to Bill Borowsky, Toni DePaola and Val Coulson. Mayor Sabosik opened the meeting to the public.

Dennis Vitkauskis: 2117 Foster Road – "Just being a nosy citizen, what is going on at Wenkes? Are they renting our some of the cabins still?"

Mr. Dasti stated the following: "The Wenkes site is now before the Zoning Board and the applicant wants to put more units in there than are permitted by ordinance. The applicant also wants to substantially increase the affordable housing units than are necessary or even needed. So, to answer your question, the Zoning Board is going to be in litigation with the developer as a result of the application before the Zoning Board and we are going to be meeting the next week or two with the attorneys on this affordable housing issue."

Dennis Vitkauskis: Stated that when he drives by at night, he sees lights on and people in there and wonders if people are actually living there.

Mr. Pannucci: "Presently there are contractors working on the property but no one is living there."

Caroline Rothlisberger: 626 South Manetta Drive: Asked for a status update on the proposed stop sign on Manetta Drive.

Mayor Sabosik: Stated that this evening they have a meeting with our engineer regarding this issue and that he will have him come up with his display that he will be showing.

John LeCompte – Borough Engineer – Approached to speak on Manetta Drive. Stated that the State will be removing the stop signs and we will be putting a striped island in with a yield sign so that the cars approaching will know to yield to possible cars coming around. There will be no stop signs, so no one will have a problem with parking in that area. There will most likely be an ordinance in place on the next meeting for the yield sign. Once everything is approved, the Borough can start working on the paint and yield sign.

Caroline Rothlisberger: Asked if just putting an island in, instead of a painted stripe island, would work better.

John LeCompte: Answered that an island can possibly cause a drainage issue in that area, so they are going to use that as a last resort.

Mayor Sabosik: Stated that Bob Forsyth, along with the Borough Engineers, Police Chief and all of Council have been part of the negotiations with this so we can always modify it later on, but we feel that this has the best chance of curing the problem. This will help tremendously. The Chief will have more enforcement over there to help inform people of the change.
