Council Member Coulson stated the following: "I believe the only thing we have right now for Land Use is the committee is going to meet sometime in the next two weeks to discuss the Flood Ordinance and how it pertains to our town."

Council Member DePaola stated the following: "I would like to congratulate Chief Lokerson and his staff. The State of New Jersey Department of Corrections sent in a contractor to determine whether our jail was up to the New Jersey municipal detention facilities standards. She read the letter from them, and it stated, "As a result of my inspection, it is my pleasure to inform you that Point Pleasant Borough Police Department was found to be in full compliance with the requirements of NJAC 10A:34. You and your staff are congratulated on this achievement and are to be commended for the efforts made in preparation for this inspection. The hard work and dedication by this staff of your facility was evident to the members of the inspection team and certainly deserves special recognition." Thank you Chief for a job well done. Also, our Police Department would like to raise awareness for autism. This Month is Autism Awareness Month and they have wrapped one of their patrol vehicles in blue so when you see one of the police cruisers wrapped in blue just remember it is for autism awareness. The officers are also being certified as sensory inclusive first responders so that children with special needs can be attended to in a special way. That's an awesome undertaking. The Point Pleasant Police bike rodeo is coming up and is open to all residents; children of all ages bring your bike and your helmet. This will be on Sunday, May 15th from 8:00 AM -12::30 PM at Nellie Bennett Elementary School. This is another great activity for the kids and another great activity put on by the police department."

Council Member Borowsky stated the following: "The Easter Egg Hunt this past Saturday was a huge success. We had over 400 children attend, and it went off fantastic. I would like to thank the Recreation Department, Police Department, Police Explorers and DPW for all their hard work making this event such

a huge success. Tomorrow the seniors are leaving for their senior bus trip to Resorts Casino in Atlantic City. I would like to wish them all good luck. I'm sure they will have a good time. Chief Lokerson congratulations on a job well done on the jail."

Council President Charlene Archer stated the following: "As I've been announcing these past few months, the Environmental Commission has been talking about Earth Day, which is on Saturday, April 23rd from 12:00 PM-4:00 PM. This is the first one in two years. We had to cancel 2020 and 2021 due to Covid so they are very excited. This will be a great family event. There will music, food, and vendors and I hope everyone comes out and enjoys this great event. The Environmental Commission has also been talking about the Barnegat Bay Group who produced a film based on 50 years of the Barnegat Bay and its history. The Environmental Commission will be showing the film, they have not determined a time and place yet, but I will keep you informed."

This gives you a chance to talk one on one with Council, Town Administrator, and myself. I would like to talk a little bit about the Egg Hunt. I totally concur with Councilman Bill Borowsky's assessment. It was a great day, it was multi-generational, there were many smiling faces, and everyone had a great time. It had the tallest Easter bunny I've ever seen. It was great; it was a coming out time for a lot of people and the rain held off. The State of New Jersey will be imposing a ban un single use plastic carry-out bags starting May 4th. The State of New Jersey has one of the strongest laws going forward. On Earth Day, April 23rd there will be various organizations giving out and selling cloth bags so we can comply with this. This law has been in the works for about 2½ years. It will prohibit all stores including retail, food store businesses and grocery stores, from selling or providing customers with single use plastic or paper bags This is good for the environment.
