Council Member Wisniewski stated the following: "First off, I would like to congratulate whatever Borough resident hit the \$50,000.00 winning lottery ticket down the street.

Second, I would like to congratulate our newest Police Officer. We do have a great department, so I am sure it is just going to be another fine addition to our department. Along that line, I did read today that there was an attempted carjacking in Bay Head. So, I do want to tell everyone to please be careful out there.

We had a couple of kayakers show up at our Open Space Meeting. They are interested in possibly working with our Open Space Committee to create a kayak stand so that seniors and other kayakers can lock up their kayaks without having to drag their kayak back and forth. You would just leave your kayak there locked up and you can pay rent. He said there have been other communities that have done this. I thought it was a good idea. We have a couple beaches like Northstream, or Maxson Avenue and I think this would work very well. What I thought was even a better idea is I know a couple of people who want to do something for loved ones who have died. Jack McHugh came up with a great idea of a memorial tree at our parks. We could have a set fee of certain approved trees based on the park because the original trees that were planted at Riverfront Park are dying and they only have two trees left. So, his thought was, we have a pick of a couple different trees that we know will do well and it will be X amount of dollars. With it, you could get a standard concrete plaque that says In Loving Memory. He planted one for Michelle and he would like to do more of that in the Borough. I think it is a well-deserved cause and I think many people would support this idea.

On tonight's agenda you will see that the budget is up for adoption. I know I am in the minority here because I still believe we need to do some work on it. The fact that we haven't had the meetings is basically my fault, I have just had personal, professional and health issues which didn't leave me time to set up the meetings to go through the rest of the budget. You may have heard our CFO and I have had some spirited discussions on our opinions. I respect his opinions and I hope he respects mine, but in my view, I think this should be tabled and not voted on tonight for several reasons I won't go into. I will save the crowd the enthralling discussion of accounting and municipal budgeting."

Council Member Furmato stated the following: "Paving has started for the season. Crestview Terrace paving is in the works right now. They are doing the curbing first. Also, I wanted to congratulate our new Police Officer."

Council Member Coulson stated the following: "Last month I spoke about drafting a flood ordinance that would address changes that would comply with FEMA and the DEP as far as language. The ordinance will be introduced this evening. I also would like to congratulate our new Police Officer as well."

Council Member DePaola stated the following: "I also would like to offer my congratulations to our newest officer. A wonderful addition to our police department here in the Borough. As Councilman Wisniewski stated earlier, there have been a few carjackings or attempted. So please, do not leave your key fob anywhere near your vehicle, lock your vehicles, do not leave any valuables in your vehicles. It is becoming an issue statewide. It is not something that is just an issue here in the Borough. We have people from out of town and North Jersey coming down, stealing vehicles, and using them to commit additional crimes. So, if we can curtail them doing this criminal activity and saving you the headache of losing a vehicle, that would be wonderful, and I am sure the police would like our cooperation with this.

The Relay for Life of Northern and Ocean County, part of the American Cancer Society, is having a clothing drive on Saturday, April 30th from 12pm to 4pm at the Mantoloking Road Ale House at 247 Mantoloking Road in Brick. Council President Charlene Archer stated the following: "I too would like to congratulate our new Police Officer. I hope he has a wonderful and successful career here in the Borough. Earth Day was finally here, and it was a great success. We had about 2600 people attend. We had 48 vendors and children had a great time in the bounce house and the petting zoo. I want to thank the Police and the DPW for all their help in making the event as successful as it was. On this same day, the Littoral Society laid brush and shrubs down at Slade Dale along with the help of other Environmental Commission people. It was a very busy day for them, but they did get enough brush and shrubs to do the front section of Slade Dale to help improve the marsh."

I know that under the astute leadership of our Chief, he will be one of the finest Police Officers in the history of Point Pleasant. Baseball started Saturday. Some of us had dual things going on besides Earth Day. We had the biggest crowd ever. We had over 500 kids in different teams, and I am happy to report that our Councilman Joe "Ace" Furmato threw out the first pitch and it was a strike! I was pretty impressed. He definitely did a little bit better job than I would have done.

I also want to thank the American Littoral Society for helping rebuild the marsh behind Nellie Bennett. We really appreciate all the volunteers from the Environmental Commission.

It is \$20.00 per person and refreshments will be served. F. MUNICIPAL BUDGET

1. (136-2022) Public Hearing and Adoption of 2022 Municipal Budget

Himanshu Shah gave his review and stated the following: "I think after the long hard work in putting the budget together and being that Council already introduced the budget last meeting and with all the detail that was provided at this point, this budget is ready for adoption. We are self-reviewed and have submitted to the State as required. I just want to give you a summary of the budget. The budget calls for \$22,809,706.00 in expenditures. Revenue includes \$1,227,576.00 in Municipal State Aid. \$650,000.00 in new home construction code fees. \$1,993,988.00 in Miscellaneous Revenue. \$79,000.00 in Municipal Court Fines and Costs. \$40,000.00 in interest on investment and deposit. Just to caution you, most towns do not include interest on investment, but we have worked hard to maintain some level of interest in this almost 0% interest rate situation. \$400,000.00 received in delinquent tax and \$15,669,142.00 as the amount to be raised by taxation. Physically that is the taxes left. We are anticipating \$2,750,000.00 from front balance to balance the budget. And this will still leave on hand, \$2,247,636.00 in cash fund balance that will help for the future budgets. The proposed municipal tax rate is estimated at .468 in 2022 which reflects a tax increase of .004 cents over 2022 budget which was at .46."

Mayor Sabosik: "So translation to the American Language, we are going up about 3 quarters of 1 percent."

Himanshu Shah: "Yes, so for average homeowners, that means about \$15.67 increase in taxes. This is a good budget, and it was a hard budget. Coming out of a pandemic and all the trouble we had just like all the other municipalities in the state. We went through a loss of revenue and income in many areas. We have some American Rescue Plan money. But overall, I think we are on our way to recovery, and it looks good. I think we just need to be cautionary in our spending plan and monitor it for the next couple years to fully recover."

Council Member Wisniewski: "I just want to go over the budget and I think we need to review it a little more. In my opinion this budget, when you mention fund balance and surplus, it is an oversimplification when you say, we are going to take some of the Borough's savings and put it in the operating budget, knowing that we will probably regenerate that and then put it back into savings. Last year, we did not regenerate the full amount of surplus. And, on top of that we also took extra money out of our Borough assets."

Mayor Sabosik: "I think this is a good budget, and I think you just have to realize that we have people out there struggling with dual income. I think they are all coming out of covid. When you say we are using some of our savings, we are. But the savings are to help our people. The people who live in this town. The people who have dual income and have little kids. I think that the small tax rate this year is worth it. I know we will regenerate a lot of it. I don't have any problems with this budget. I have been doing these many years. I have a financial background as you know. This will be a good budget and it will not put the town in any risk."

Council Member Wisniewski: "I guess that is where we are going to differ. My concern is raising the bar higher and being better."

Himanshu Shah: "It has been many years that we have been working together and we have done a great job recovering. Remember what it once was. We are never going back there. For 10 years we have gone through a lot of these ups and downs and you, and I have always seemed to be the on the same page. This is the first time I am seeing that we have different views. I understand and I do respect your opinion and your concern. I am certainly going to be more vigilant to make sure that our spending stays under control for this year, and we will start looking at everything a lot earlier for next year's budget. I believe that is what will help. At this point, I don't think we should table it. I don't think we are going to make any major changes. We are already 3 months into the budget. By the time you are going to change anything, it is going to be 5 or 6 months and it will impact us even more and require even more cuts. So, I recommend that we proceed with this budget, and I ask all the Council Members, particularly Council Member Wisniewski

support and looking over how we can better manage the next couple of years, so we are completely out of the woods."

Council Member Wisniewski stated the following: "May we have a discussion please? In the bills and claims I saw money for X-Chair. I am just wondering about this. It is two chairs for over \$2,000.00 so it is over \$1,000.00 a chair. I know it is for the dispatchers, but my thoughts are, is this the recommended chair. It just seemed exorbitant for a chair."

Chief Lokerson responded with the following: "We did research on this, and this is actually one of the cheapest chairs that are out there. The chairs are about \$2,000.00 for the 24-7 chairs. These chairs are sat in 365 days, 24 hours a day by our dispatchers. We must buy them a decent chair. If we buy cheaper chairs, like the \$700.00 chairs, we will be replacing those chairs every quarter. Some of them we did a lot of research on, and this company is reputable. I felt it was the best use of the monies allocated there and for the person sitting in the chair for the long hours they have to sit."

Mayor Sabosik asked: If this is an ergonomic chair?

Chief Lokerson responded: "There are a lot of benefits to these chairs. They are wider and are not like standard chairs."

Council Member Wisniewski stated the following: "You can understand why I am questioning this. When you look at the price."

Mayor Sabosik stated: This will help reduce workman comp cases.

Chief Lokerson responded: "This will reduce medical issues and gives them better support and lower back support. This chair has a massager. It is reinforced. I can show you the damage on the previous chairs. It comes with recommendations for usage and a video. The chairs are registered and have different

warrantees on it. These are 24-7 chairs, and they need to be sturdy. The chairs that they originally wanted were \$2,500.00 each."

Council Member Wisniewski stated that it was only passed for first reading, and we have 30 days to review.

Mayor Sabosik stated that residents could come up to talk about it if they wanted.

Jerry Dasti stated that the proposed ordinance is on the desk in front if anyone wanted to review it.

Tom Falvey: 1146 Bradford Drive – Asked the Mayor and Council if this was deemed an unsafe environment.

Mayor Sabosik called Chief Lokerson up to respond.

Chief Lokerson: "There are a lot of streets in the Borough that have very narrow roadways. Front Street is one of them. There has been a parking issue that has arisen. It prevents traffic from going two ways and that can pose a hazard. There are other streets in town are similar which is why Councilman Furmato is concerned that other roads could also end up having similar issues. It is my recommendation at this point based on what we have seen is to make it one sided parking. It does not mean that we will not reevaluate certain areas in town as well as Front Street as things progress as far as, is parking now pushed further into the neighborhood or does it create other issues. This is something that we will continue to look at. There was an old ordinance regarding Osborn Avenue. The ordinance stated no parking on the sides of the roads to allow for ambulance to get through. But now there is no ambulance coming down that road. We are always reevaluating. And with this issue, there could be concerns but at this point, based on research that I did, these are my recommendations. It is up to Council to decide.

Conversation between Tom Falvey and the Mayor and Council went on about issues and concerns regarding getting around on Front Street

John Finley: 1120 Front Street – Complained that residents of the town homes do not utilize their parking spaces the way they were approved to do so. They do not park in their garages, so they use the side streets. Residents of Front Street end up losing parking this way.

Chris Finley: 1108 Front Street – Asked for Clarification of the Ordinance regarding the 230 feet.

Mayor Sabosik stated that the 230 feet goes to Estelle Drive.

Chief Lokerson also gives clarification on Ordinance.

Seeing no other hands, Mayor Sabosik closed this portion of the meeting.
