STATEMENT BY MAYOR SABOSIK: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 7, 2022, edition of *The Ocean Star* and January 7, 2022, edition of *The Asbury Park Press*.

Mayor Sabosik stated the following: "Tonight I have the pleasure of reading a proclamation to individuals who provide safety in our local waterways. They are the unsung heroes. They volunteer and they create a safe environment for so many people and they have done this tour of duty for so long. I want to personally thank you for your service and for helping make our Point Pleasant waters safe."

B. WORKSHOP

1. Committee Reports

Council Member Wisniewski stated the following: "A brief update from the Open Space Committee. There was an idea passed around to start a program to plant memorial trees at some of the parks. That was led by former Council Member Jack McHugh who is also part of the Open Space Committee. He has met with different members of DPW to discuss what trees would be the best trees to plant at each individual park. So that process has been started and I think it is a well thought out, great idea. We will get more trees in town and lets residents honor a loved one.

As far as the Finance Committee goes, I am looking to set up a meeting with our CFO to try to wrap up the budget that we passed at the last meeting."

Council Member Furmato stated the following: "I have nothing really for tonight. We haven't had a lot of changes yet because the paving of roads takes a while. We have a DPW meeting on the 16th, so I will have a bigger report for the next meeting."

Council Member DePaola stated the following: "Last week the Mayor, Councilman Furmato and I met with our Emergency Medical people over at the First Aid building to talk about possible solutions to some of their parking issues, some of their equipment and the new truck that they would like to have redone. I

think we have come to an amicable agreement. The Fire Company has agreed to allow some of their trucks to be parked on their property across the street, but we believe that they would have to go to the Planning Board for final approval on that. This was something important to them and something we were able to get out of the way. I am glad we were able to meet up last week."

Acting Council President William Borowsky stated the following: "The 2022 Summer Recreation schedule will be out by this Wednesday. All the camps that were offered in last year's schedule will be offered again this year. Good news to report this year, full day campers will be going on trips again. Covid had put a stop to it for a while but now trips will start up again this year.

Beach badges go on sale May 31st. They can be purchased through the Community Pass online or through the Municipal Court at the window. Badges for 6 and older are \$20.00, children 5 and under are free, badges for those 60 and older are \$10.00 and beach badges are free for our military.

On May 30th we will have our Memorial Day family bike parade at 11am. That will be followed by a ceremony at 11:30 at the Community Park right across the street.

Pre-School for next year is full already and the graduation for this year's pre-school will be on June 8^{th} also at the Community Park."

2. Report of Mayor

Mayor Sabosik stated the following: "Mayor's hours will be May 11th at 5:30pm to 6:30pm in the courtroom. I do want to tell council that I did sign off on the grant. Our \$50,000.00 grant was approved. We will be doing some housekeeping. At Waters Edge, the condo association will be putting some new benches in. May is also Mental Health month so we need to realize that with Covid a lot of people are feeling a little bit out of sorts. Let us tell them that there are plenty of programs with the county of ocean to be able to help them through their time of need.

I also have a letter here from the Clean Ocean Action Committee thanking us for participating in the Beach Sweeps Program. This shows that we are totally committed to making this environment the best that it could be for today and tomorrow for future generations. We feel the water component of our area is so important. We need to take care of it today so that it is here tomorrow."

PUBLIC COMMENT:

Chris Finley: 1108 Front Street – "I have been in contact with you all many times. I just want to summarize some points I brought up with everybody. The only thing that I have heard that was in opposition of this plan was that if this goes through, then other residents of the town would also be looking for different parking restrictions in their area. I think that what we have here is unique to the area. You have the Bluffs that have overspill of their parking lot on Front Street, and you have a commercial business on the corner which has overspill. You have a mailbox on the corner, and you also have an undersized street which we have already shown that emergency vehicles would not be able to get down. It is not just one issue, it is multiple issues and multiple factors. This should be seen on a case-by-case basis and this is unique. If you vote against this, you vote against a traffic safety issue that has been recognized by the Police Department and by the Public Safety Committee."

Jessica Bennett: 1117 Arnold Avenue — "I think Chris summed it up nicely. I live directly on the corner. As I am going to work daily, I see people entering and exiting that roadway on Front Street onto Arnold at increased speeds. At either direction, they don't see well. Personally, I witness a lot of congestion on that road which concerns me. As I am trying to get out, I am often blocked into my driveway as another area of concern. I see it also with the businesses as well as the additional congestion from those trying to access the mailbox there. They try to come in quickly to drop off mail, but they block the road there as well. I live close to that area and observe this every day."

Ann Finley: 1120 Front Street – Shared a memory of a car accident she witnessed due to cars being illegally parked. Asked that the Mayor and Council be proactive to avoid a situation like what she had witnessed and please vote for this ordinance.

Dennis Vitkauskis: 2117 Foster Road – "Last week I stopped to talk to the Mayor about the fact that the Bank of America across the street put in a new driveway and there were no curb cutouts for the handicapped. He said he would speak with them and make sure that they fix it. So, thank you."

Mayor Sabosik: "Now this will take a little bit of time, but our people and their people have talked, and they will be redoing it. Thank you for stopping by. ADA compliance is very important for our town. We have a lot of senior citizens."

Danny Palkoski: 2224 Riviera Parkway – "Over the past year I have had a flooding problem in my back yard. I went to the DPW to look into it, and someone came to look and said that, yes, something is wrong. So, I went to the Town Administrator 3 times and still have not heard from him. This has killed all my grass and the bugs are starting to come out already."

Mayor Sabosik confirmed his address and asked Bob Forsyth and John LeCompte to come up to speak with him because they are engineers and hopefully, they have an answer.

Bob Forsyth: "I requested in our capital budget, \$150,000.00 for drainage improvements and we got it. This was one of the projects I had in mind. This is part of Laguna Village and there is an easement back there and everything drains down to that and unfortunately it just kind of sits there. It is a very low-lying area. I think we can do something like what we did on Pocahontas. John and I are going to go over that."

John LeCompte: "We originally did a drainage area for the Beaver Dam Laguna project. Some of these locations are within that overall drainage area we did, so we are going to look at that and do some additional field work."

Conversation took place regarding the drainage issues, and they will be looking into the problem.
