### A. WORKSHOP

# 1. Committee Reports

Council Member Borowsky stated the following: "Our Fall Rec program registration will be starting September 14<sup>th</sup> for Point Pleasant Borough residents and September 21<sup>st</sup> for non-residents. Pre-school and Pre-K will be beginning the second week of September. I would like to give a shout-out to our Public Works employees, for all the improvements they did at the Rec Center just recently and specifically I would like to thank Jim Colwell and Jim Teague for helping Sheri Silversmith, she said they did a tremendous job helping her transition from the summer camps to setting up the preschool programs.

I would like to send my heartfelt condolences to the family of Raul Cartagena. Raul was a Point Pleasant Borough resident; he was also a wrestler who passed away tragically last week. It is so sad and devastating. I saw online one of his friends started a GoFundMe page and they were trying to raise \$15,000 to help with his funeral costs. Point Pleasant, this great town, has donated over \$50,000. This is an amazing town we live in.

In a couple of weeks, school will be opening so please drive safely."

**Council Member Furmato stated the following:** "I don't have much tonight but on Consent Agenda No. 10 we are going to award the contract to rehabilitate Well #9."

**Council Member Wisniewski stated the following:** "On the Open Space Committee our Admin. has resigned her name is Kerry Hoffmaster and she is moving to South Carolina. If anyone knows of anyone that would like to take her place, please let us know. This is a great committee to be on, a lot of great people. The meetings are at Bennett Cabin, every second Wednesday of the month.

Following up on the memorial tree program, for all of you that don't know, former Councilman Jack McHugh is trying to start a memorial program, I'm sure you've seen benches around that state "In Memory Of". Here in Point Borough, he is trying to start a tree program where you dedicate a tree to a loved one. He's walked the parks with the Head Horticulturist from Rutgers, Diane Larson and she determined the best trees that would thrive at our parks. They are working on pricing and the type of memorial sign that would be placed by the trees. Jack has already done this for his girlfriend that recently passed away. Once completed, I will let him introduce it."

Council Member Coulson stated the following: "For Zoning and Land Use, as we all know, Tim Skinner has retired, so the committee spent the better part of July and the beginning of August interviewing for a new Construction Official, and I am happy to say we have a new one starting on September 6, 2022."

Council Member DePaola stated the following: "Thank you to our town, thank you to our first responders and our police department for a wonderful National Night Out. It was a great night out. It is nice to see all the wonderful events going on and having a really family oriented evening at the park. There will be a Public Safety Committee meeting this week to discuss changes to the towing ordinance with the input of the Chief of Police. We will see if any changes are necessary at this time."

Council President Archer stated the following: "I too want to thank the Police Department and the Community Watch for a successful evening. Many of the residents really enjoyed being together and getting out again.

Environmental Commission is kind of quiet right now, but they are trying to get into two New Jersey projects. The first is called Sustainable Jersey and their common goal is to get more involved with this by attending a meeting to find out the requirements to get into the Sustainable Jersey program. Also, the other one is called Tree City. They want Point Pleasant to be nominated or assigned as a "tree city". There are only 14 cities in New Jersey that have acknowledgement. We would like that. Point Pleasant Beach is a Tree City. So again, they will be meeting to see if Point Pleasant Borough could get that status."

# 2. Report of Mayor

Mayor Sabosik stated the following: "I have some news on the beach replenishment program which is needed on the barrier islands. The ocean beaches are enjoyed by all of us. They are for everyone who visits the shore. The beach replenishment program is sorely needed for the safety of the barrier islands and also for our town. We do not want another breach like we had with Sandy. In the last few years, we've established a Barrier Islands Mayors Association, which includes all the barrier islands, and Point Pleasant Borough We are united in creating safe beaches and beach replenishment. This united voice has gotten the attention of the government agencies and they've promised to move forward with the beach replenishment program. Unfortunately, the first rendition of the finances for the barrier island mayors would be a detriment to their budgets. Therefore, all the mayors sent a letter to the Governor and basically this is what it said:

"Tourism is the main economic engine in Ocean County. Accounting for \$6 billion dollars in revenue mainly generated in the summer months. The beaches in Ocean County along the Jersey Shore are enjoyed by all the residents of the State of New Jersey. Recent news reports have stated that New Jersey has an excess revenue between \$7 and \$8 billion dollars this fiscal year. Therefore, we have requested the State of New Jersey pay the balance of the USA Corps of Engineers costs not covered by the federal government to alleviate the financial burden on our fellow municipalities on the barrier islands."

This is important to our town. Sandy was a devasting storm due to the breach in Mantoloking we never want to see this again. Therefore, I and the rest of the mayors are beseeching the State of New Jersey to step forward and undertake this cost. We also are talking to other government agencies for help, and we are sure that other government agencies will step up and help them pay this vitally needed program.

On a local front, I don't know if you've seen the new police cars, The Chief and I were able to secure some police cars from Pennsylvania and the cars were relatively inexpensive compared to the costs in New Jersey. I believe they are here and if you see them, they will have the new colors and logo to keep our police department in a "today" look, a present look. I thank the Chief for his input.

Fireworks, October 15<sup>th</sup> will be going on in conjunction with the Chamber of Commerce and I will be announcing corporate sponsors at our next meeting. The Rotary Car Show, like National Night Out was the biggest one ever. It was the most cars we've ever had in this town. I would like to thank the First Aid, Police Department and DPW for doing such an outstanding job.

On a sad note, I too, feel a sadness for the young gentleman who lost his life. He was a rising star in our town. Raul Cartagena was a fine young man that was taken way too soon. I would like a moment of silence to think of him."
