Mayor Sabosik stated the following: "Please let us continue to remain standing to remember September 11th. Let us continue to remember the fallen ones from that fateful day. Amen.

I also want to thank the Bay Head Shores Clubhouse for having a 9/11 Remembrance. It has been many years, but we can never forget those that went down that fateful day."

STATEMENT BY MAYOR SABOSIK: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 7, 2022, edition of *The Ocean Star* and January 7, 2022, edition of *The Asbury Park Press*.

A. WORKSHOP

1. Committee Reports

Council Member DePaola stated the following: "First off, there was a public safety meeting held on September 8th. I was in attendance as well as the Mayor, Councilmember Wisniewski, Councilmember Furmato and our Borough Administrator. Many issues were discussed including a transition plan. Many of you may know that our beloved Chief of Police is looking to retire. He has worked diligently to make certain that there is a plan in place for his succession. I thank him for taking the extra time to prepare for that. Also, we discussed various speed studies that have been done. There was a study done on Herbertsville Road. The County authorized the 35 miles per hour, saying that it is not a speeding issue on Herbertsville, but a volume issue. Also, Hardenberg Avenue has had 2 speed studies done in 2021 and those studies show that there was an increase in volume which leads people to think it is speeding but it is more volume. The Police Department has been out there numerous times but they will conduct another speed study in the near future. Also we have our office of Emergency Management who keeps us all safe when there are various events going on that need the expertise of Emergency Management. In the month of August, they put in over 173 man hours. The CERT team put in over 73 man hours. They also responded to nine general weather related events, one public education event, five tropical weather events and five power outages. They have also officially moved into their new emergency operation center at the municipal building. Now that they are up and running there, they should be able to handle operations much more smoothly. If anybody is interested in volunteering with our Emergency Response Team, feel free to check out their information at

www.ptborooem.com . Their monthly CERT meetings are held on the second Tuesday of every month at the Borough Hall at 7:00pm. Anybody who is interested in volunteering please feel free to reach out to Andy Welsh who is the director. Also, as we move forward, there were many kittens available for adoption at our Point Paws Animal Rescue group. They have kittens available right now as well as adult cats. If you adopt a kitten, it is \$125.00 which includes shots and everything. If you are willing to take 2 little kitties home, they will waive the adoption fee for the second cat. So, anybody interested in adopting and making a cat or kitten part of your family, please check out Point Paws Facebook page.

Lastly, speaking about 9/11 which was a tragic event, and we all remember where we were on that tragic day. We also want to remember Tech Sergeant Joseph F. Grubel. He was only 24 years old. He passed away on August 7, 1944 as a result of WWII. We like to remember our local service members that are part of Point Pleasant Borough community."

Council Member Wisniewski stated the following: "Like Councilwoman DePaola said, the events of 9/11 is something we all wish we didn't have to remember and hopefully we will never have to experience again. If there is anybody having trouble getting through these days, feel free to give me a call and I am sure everyone else up here would be there too.

Borough business, our Audit came back, as usual with our Finance Department, there is no comments or corrections to it. We have become a well-oiled machine on that side of the house. The only thing I have ever done is stay out of those really talented people's way.

The Open Space meeting is Wednesday. You will see on the agenda that we are replacing our Admin and it is actually Kerri Jones niece Molly. We look forward to that happening.

I got in touch with Jack McHugh and he promises to have an update on the memorial tree program on Wednesday.

Also, I would like to say congratulations to the Point Pleasant Borough Football team. They really handed it to Manasquan. It is always good to beat a local rival.

Finally, if we ever have a power outage, don't call the Chief because there is black smoke billowing out of the bridge. It is just the generator."

Council Member Furmato stated the following: No report tonight

Council Member Borowsky stated the following: "Fall registration for our Recreation Programs open Wednesday, September 14th for our Borough Residents and September 21st for our Non-Residents. Registration for everyone closes on September 28th. All programs will start the first week of October. Preschool started today and Sheri said it is always an exciting day having all the children back. She said that the transition was very easy today because there was a lot of Preschoolers that enrolled into Pre-K, so they were already familiar with the facilities.

There will be a Senior Center bus trip to the Tropicana on October 4^{th} . Seniors can reach out to the Recreation office for information. It is \$20.00 and you get \$20.00 back, so it is a good deal.

Haunts in the Park this year is Thursday, October 27th. From 5pm-6pm is the non-scary portion for the real young kids. And then from 6pm to 9pm for the scary portion. Recreation and Public Works always does a phenomenal job with this event. Tickets are on sale the first week of October at the Recreation office and they will also be on sale the night of the event.

The last part of my report, I have been in communication with Dennis Blazak regarding the Federal Grant that he received for the town with the restoration of the Nellie Bennett field. So, rather than write it down, I asked him to come to the meeting and explain to the council some of the details in particular. It is a pretty exciting thing for Point Pleasant Borough. I was hoping he could talk about it, or if you would rather, he can talk during open public session."

Mayor Sabosik: "Open Public Session will be good for this. I have also talked to Dennis many times about this, and it is a great grant for the town. I think public session would be a better time."

Council Member Borowsky: "Okay, sounds good. That will conclude my report for now."

Council Member Coulson stated the following: "Our new Construction Official, Andrew Rempfer started last Tuesday and hit the ground running and already put forth a proposal. We already have the SDL system in the office, but he proposes to get i-Pads, so that when the inspectors are out in the field, they can enter anything into the system from the iPad. Eventually, as we enhance our system, residents will be able to go online and see where their permits or applications are in process. This is something that we are looking into. If you really want to know more of the nuts and bolts, Frank will be able to give you more information on that."

Council President Archer stated the following: "With the Environmental Commission, the LAS hosted a Shellebration on 9/13. They were asking for volunteers between 3pm and 5pm. They were putting out oysters to help with the reefs around the area. They had a reception today at Forked River Beach.

The Environmental Commission is looking for any Eagle Scouts who are looking for a project. They would love for them to reach out to see if they could give any suggestions on some Eagle Scout Projects.

Thank you for bringing up the Barnegat Bay Partnership Grant. It is coming along. They have no big updates. Maybe Dennis might have another one since my meeting with him last month. But at this point, they had stakeholders meetings which is the starting of the procession of the grant, so I am looking forward to hearing more at Dennis's report later on.

Sustainable Jersey are having a meeting late September to discuss what needs to be done to have NJ be more green."

2. Report of Mayor

Mayor Sabosik stated the following: "Speaking of the environment, on 10/22/22 from 9:00am to 12:30pm we are going to have Beach Sweeps once again in town. This is very important because with our clean communities award, anybody who gets \$25,000.00 a year must have two volunteer cleanups. This year, the qualification is from January 22 to June 30th of 2023. So, anybody who would like to sign up, please notify me or my office here. I know we will have a great turnout. This is for the betterment of the environment. And as you all know, this administration is 110% for making sure our water is accessible for fisherman and boaters.

I will be having a meeting with the county commissioners tomorrow with the rest of the Mayors from the barrier islands. I explained before, the reason why we are included here is because the barrier islands provide protection for us so that Sandy does not ever happen in our town again. This beach replenishment program is vital as well as for our town. We look forward to a very positive meeting with the commissioners. They have already said that they will be funding a portion of the towns on the barrier islands so I will report back exactly what those numbers are at the next meeting. This is where local government, county government, state and federal are protecting our environment and the future of our communities in a positive manner.

September is hunger action month. I will be going up to Fulfill in Neptune. They will be going forward now at 100% outside of covid. I will be having that meeting on Friday. I look forward to meeting with the folks again, and I will report back exactly what programs we will be bringing to the town of Point Pleasant.

We have a troop fundraiser. What it is, is you go online and you go to a website called Pampered Chef. They will be giving a portion of the money to raise funds to send over gifts to our overseas serviceman. This will help them feel at home. They will be receiving different types of food and other packages. Lloyd Mulligan is in charge of this. I applaud him for this program. It is very important. If anyone would like to know the website, you can come to town hall or call us. It is pamperedchef.com/parties/troopboxpoint2022.

New Jersey Natural Gas is coming out with assistance. If you know anyone who is a problem economically, they will be providing help with energy assistance dates. The first in our local area is in Bricktown on Friday, September 30th from 10am-5pm at Church of the Visitation, 755 Mantoloking Road.

I will be having Mayor's Hours on 9/21 from 6:00pm-7:00pm.

Lastly, the town has received a check from the Board of Commissioners for \$12,709.03 for the first six months of the Ocean County Recycling Program. This is our largest ever payout of \$29.47 per ton. This goes to show you that this administration is for the environment. We will continue to be environmentally sensitive. We will continue to have programs to ensure the quality of this town will be for future generations."
