**Mayor Bill Curtis: Mayor of Bayhead** – “It was so good to hear Judge Bob Fall and Jerry Dasti exchange views. I will not have Jean Cipriani come up here to share hers or we will be here till 5:00pm! I just wanted to thank you. I am sure most everyone here knows the arrangement that Bay Head and Point Pleasant Borough has. We are so thrilled to have Frank Pannucci and the shared service agreement for our Borough Administrator. This has been a big help to the Borough of Bay Head. I thank Bob and the rest of Council for allowing that to happen. I also want to point out that Toni did a superb job as our fill in Borough Clerk when ours was out on disability for some months. Toni, I can’t thank you enough for all you did, and I really thank you for not letting Frank continue in that role. I also want to congratulate you Bob, on your victory, and I look forward to the next four years working with you. Charlene and Joe, here is to your next three years. And to Antoinette DePaola and Val Coulson, thank you very much for being here and for helping Bay Head whenever you could. It is always good to work with all of you, thank you very much.”



**Mayor Sabosik stated the following:** “I would like to inform everybody on exactly what that entails. When you have a smaller town and a medium size town next to each other, the ability to share services creates a positive atmosphere for both towns. When you have staff that other towns want to promote and enhance their financial net worth, by combining two towns, we are able to fight off the erosion of staff to bigger towns. This leads to a closer relationship to our surrounding towns. It is beneficial to Bay Head, and it is beneficial to Point Pleasant. When you have a global perspective outside of your own town you can gain by sharing. By doing things outside the box. I believe we are the first two towns to ever to share a town administrator in the history of the State of New Jersey. I thank the Mayor and his council and I will be at his reorganization meeting tomorrow.”

**David Guetzlaff: 2234 Riviera Parkway** – “This is like a double edge sword for me because I want to get your approval and I would like to get the Rotary Club’s approval at the same time so I have to kind of introduce this so one can do the other. You all know I am really into the history of Point Pleasant and it recently came to my attention that at the River Front Park, when you are looking at the island that is out there, it was actually known as Osborn Island. I am looking to get a sign or a placard made for Riverfront Park that will explain the history of Osborn Island. If this is approved, the Rotary will provide this to the town. Treasure Island, New Jersey in May of 1888, Robert Louis Stevenson spent about a month in Brielle, New Jersey along the Manasquan River. On the River just north of Point Pleasant is a small, wooded island at the time, then commonly known as Osborne Island. One day Stevenson visited the island and was so impressed with the whimsical that he rechristened it as Treasure Island. He even carved his initials into the bulkhead. This took place five years after he completed his novel, Treasure Island, and to this day many people still refer to the island as such. So, Treasure Island was named by Robert Louis Stevenson and was named in his novel as Osborn Island. So we would like to have a plaque made and placed in its approximate location so people, when they go to Riverfront Park would look out on this and they would see Osborn Island and know that it is part of our history that Robert Louis Stevenson put this into his book.”
