STATEMENT BY MAYOR SABOSIK: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. 1. Committee Reports

Council Member Borowsky stated the following: "My apologies, I have no report tonight."

Council Member Wisniewski stated the following: "I had a conversation with the Point Pleasant Schoolboard Administrator regarding Governor Murphy and his idea of universal preschool. It turns out that our schoolboard administrators have been working on this for about a year now. They are hoping that by next year they will have the program up and running and hopefully in about 5 years it will be in full bloom. The goal is about 300 students in either partial subsidized or free preschool."

Council Member DePaola stated the following: "On September 21st around 11:00pm our Point Pleasant Borough Police Department responded to Spirits Liquor Store at the corner of 88 and Bridge Avenue. At the time, there were numerous 911 calls reporting a male subject using some sort of weapon to smash up the front store windows. The store was closed at the time and a 44 year old male from Brick was arrested and subject to criminal mischief and possession of a weapon and disorderly conduct charges. He has since been released from custody pending court. It just shows how important it is for the public to be aware and to call the police if you see any suspicious activity because they were able to apprehend this individual rather quickly.

We have had a lot of inquiries about our E-Bike Ordinance. As we know, there was an influx of mostly kids riding their e-bikes and we were having issues with them not following certain rules. The police department worked with our attorney, and we were able to come up with an ordinance. That ordinance that was passed was announced to the school system and they have been working closely with our special law enforcement class III officers who work in the schools. They have been educating the students and have been stopping

students if they see them violating the rules. The school district also sent home information to parents. Hopefully, with parents understanding what the rules are and enforcing them at home along with the police encouraging students at school, we will see safer roadways for everybody. As you all know, if you look at the local papers, unfortunately there has been an uptick in burglaries, including in the Borough. Fortunately, there were 2 individuals apprehended for burglaries in Bricktown and one of them unfortunately had a handgun. We are once again, with the police department, advising everybody to lock your doors. Keep your outdoor lights on and call the police with any suspicious activity and please lock your cars and bring your key fobs in the house with you. A lot of times if you leave your cars unlocked, they are taking your garage door openers and opening your garage and gaining entrance into your house. So, to keep everybody safe we just ask for extra diligence and keep the police apprised of any suspicious activity in your neighborhoods."

Council Member Furmato stated the following: "Last week we had a sanitary line break over on West End by the marina and that has been repaired. Boulton Avenue Reconstruction Project, hopefully we will have begun this fall. If not, it will go into the spring. That is a DOT funding, and the contract is awarded. This will be approved tonight.

We are purchasing a street sweeper. The cost of this sweeper is \$321,000.00 but we are getting a grant for \$221,000.00 with shared services with Bayhead.

Bay Avenue paving will begin shortly. That will be between Route 88 and Bridge Avenue.

The playground at the Riverfront Park should be here in a couple of weeks. In about a week the DPW will be closing that part of the park so they can disassemble what is there and put the new playground in."

Council Member Archer stated the following: "We have not had an Open Space meeting, so I have no report tonight."

Council President Coulson stated the following: "Our fall Rec program had over 600 registrations. Sheri said that it was the most ever. I think that is pretty indicative that we are in need of a new Rec Center. Especially when we have so many people interested in the Rec programs that we have to offer.

Our Fall festival is Saturday, October 7th from 5:00pm to 9:00pm at the Riverfront Park. We are going to have music, children's activities, a beer and wine garden and food vendors with fireworks at the end of the evening.

Trick or Trunk is in Community Park on Tuesday, October 24th and Haunts in the Park is on Thursday, October 26th.

I also want to congratulate our Point Pleasant Boro High School football team. They are really on fire!"

2. Report of Mayor

Mayor Sabosik stated the following: "The New Jersey Business and Industry Association is monitoring a Department of Environmental Protection 1200 page Land Use Development for Coastal Area. They are planning on some revisions, and we will be monitoring this to see how it affects our local town.

I am happy to report that Point Pleasant has received good news. Our Community Rating System will include a 15% discount again this year since our voluntary incentive program that recognizes and encourages community flood plain management that exceeds minimum requirements of the National Flood

Insurance Program. So, anybody who has flood insurance in our town will see a 15% reduction on the fee that they pay.

One of our longtime employees, Mary Costa is retiring and we wish her well in her future endeavors.

The Point Pleasant Kiwanis is having a Point's Giving Day on November 4th at Community Park. Hands on community service and fun for all."

Mayor Sabosik opened the meeting to the public.

Resident: 319 Barbara Road – Head of Garden Club – Handed out binders to each member of the Council from the Garden Club.

"As all of you know we are in the process of going to the New Jersey Friendly Yard Certification on behalf of the municipality. We have almost all of the paperwork ready. We have been working diligently with Mike and the DPW to get this information prepared for everyone. We will be bringing a copy of what I gave you with us to the program this fall on Saturday. Everyone in the state will be able to see the work we have done. We are in line to become the first municipality to ever be certified. Also, we are planning on participating in Pointsgiving and the pollinator garden itself. I am not sure how far into this we are yet. One of our activities is hopefully to have members of the public help put compost down. I know Ocean County offers free compost. We would like to use that compost over the winter to amend the soil and let it seep in. We might need some help from the DPW to actually get 3 cubic yards of soil. We have a couple more ideas but not quite there yet."

Mayor and Council thanked them for their hard work and all they do for the town.

Resident: 2406 Spruce Street – "First I want to thank the First Aid Squad. They did a great job when they had to come and get me after I dislocated my hip. The squad was great. I truly want to commend them, and I will be dropping off a check. I would like to show you a video regarding an incident I had with an electric bike."

Mayor Sabosik: "This resident had an incident with an electric bike on Spruce Street. Chief, if you would like to step forward, he has the latest and greatest information. We have a very strong ordinance in place. We are one of three towns in the whole state."

Chief Picca: "When an incident described like the one you had happens, police officers will respond to the scene. We reached out to the officers assigned to the high school to assist in the investigation. We wanted our Class III's to get a feel of what we are dealing with, with these e-bikes. Also, to interact with the juveniles. With that being said, he was able to review the surveillance and the person in question was identified and was already issued a warning once before. So, he will receive a summons for the ordinance violation. This is the point of this ordinance. To ultimately seek compliance. This will travel from word of mouth because kids and their parents talk. This is something that we take very seriously. Some of these bikes are questionable and we have to see where they fall under the law. That is something we are looking into. I have a letter generated that I have to tweak, and I plan on talking to the parents as well. This is a work in progress, but we do take it very seriously. This juvenile is going to be charged. It is a work in progress, but we have gotten positive feedback from our officers as well. The word is getting out and that is our goal. And we are not out to just punish people. This is for their safety as well. We are hearing these problems everywhere throughout the state. We have meetings on this, and no one has an answer. So, we are working together to try to somehow get the parents on board to make them understand what their children are operating."

Resident: 2406 Spruce Street – "They should have to complete some kind of course."

Chief Picca: "I agree because we do have mopeds and we require permits for them."

More conversation ensued on the topic of Electric Bikes

Resident: 2406 Spruce Street – "I also have another issue I wanted to talk about. I filled out an OPRA a couple of months ago. If you remember we talked about the speeding on different streets. I filled out an OPRA asking for speeding tickets issued on certain streets. I might as well have gotten nothing back. No speeding tickets were issued."

Chief Picca discussed how his officers must keep watch of over 300 streets and that they try to do speed studies often. Speed studies usually start with a complaint, they start a speed study, and the device tells the amount of cars, the direction and the speed that they are going. It also tells us the time of day so they know what time to have officers patrol. Noted that his department doubled the amount of summonses issued from this time last year.

Chief Picca also stated that he will look into the OPRA request mentioned and make sure that they are being responded to properly.

Resident: 2406 Spruce Street – "One last thing. I had a petition done up with all the names from the 2400 block of Spruce Street. Everyone signed and it was asking that something be done. We didn't make a suggestion, we just asked that something be done. It has since gotten worse. If I had to get out of my driveway at 7:30 in the morning, it is not happening because it is bumper to bumper traffic in both directions. I don't know why you can't make it a one-way. Why does one street have to have all of the traffic."

Mayor Sabosik stated that he will have our town engineer look into something like that and see what he thinks can be done.

Resident: 2117 Foster Road – Stated that it seems like the elementary school kids are all wearing their helmets now. But as you get to the older kids, you don't see as many. Also noted that it would be nice if the streetlights were all working. Stated that there was a pole on Patterson Road that was cracked and leaning. It was replaced but all the wires are still connected to the old pole.

Seeing no other hands, Mayor Sabosik closed this portion of the meeting.

Mayor Sabosik stated that there will be no Executive Session this evening.
