STATEMENT BY MAYOR SABOSIK: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 5, 2024, edition of *The Ocean Star* and January 5, 2024, edition of *The Asbury Park Press*.

A. WORKSHOP

1. Committee Reports

Council Member Veni stated the following: "At our next EC meeting on May 21st, the EC welcomed its newest member, Ms. Nicole Capoano. Ms. Capoano, with her expertise and her love for the environment, will be a valuable asset to the EC team and the Borough of Point Pleasant. Just to point out how dedicated the EC team is to our town, they already have a date planned for Earth Day 2025. This will be Saturday, April 26th, 2025, with a rain date of Sunday, April 27th, 2025.

The next EC meeting is scheduled for Tuesday, June 18th, 2024, at 7 p.m. in the courtroom. In regard to the creation of our Sustainable Jersey team, we are finalizing a few more items in order to have them completed for our July Council meeting. In regards to Ordinance 2024-17, titled Street, Sidewalks, and Sanitation, we felt it would be in the best interest of the town to amend the existing road opening restoration portion to state, any road opening occurring on a roadway that has been paved within the past five years shall pave the entire width of the roadway and the entire length of less than 10 feet on either side. We will set the trenches open to protect any newly paved roadways from premature failure for wide quality and cost of repair to our taxpayers."

Council Member Furmato stated the following: "I don't have much tonight. Most of the stuff I talked about with roads and sidewalks, I talked about at the last meeting. The ones that are in the works right now, Boulton Avenue, they're probably going to be milling tomorrow and the next day and have the paving done by the end of the week. Oak Terrace, they've done half the paving, and they'll finish up the other half in the next couple of days.

Sidewalks, bids are going out for Dorsett Dock Road sidewalks and that project should be a summer project, and surveying has been done on the River Road project and that will be a fall project. Building

and grounds, Richards Road Beach, they put 25 tons of sand down and did trimming of the vegetation. This week, Maxim Avenue is going to get 50 tons and River Avenue is going to get 25 tons.

Next week, I should have a DPW meeting to get some more answers on all the other road projects in town."

Council Member Archer stated the following: "On tonight's agenda, we have four promotions for our town people, and I want to congratulate all four of them.

Mark Lane, Jimmy Colwell, Jeff DeFelice, and Karen Langley. This is another example of how great our town employees are and how they strive to be the very best they can be for the town and for the residents of Point Pleasant. I congratulate them all on a well-deserved promotion.

Our open space meeting was held on May 22nd. We discussed Santa at Bennett's Cabin and it's going to be December 14th and 15th. Last year, Santa didn't confirm, but this year he has confirmed the dates already because we booked them so early, so it's definitely on. On May 17th, we did a lantern fly presentation through open space. Michelle Coffey arranged it with Girl Scouts and Scouts of BSA. It was a very fast thing. We tried to get done really quickly. Unfortunately, we did a little bit too late because we were trying to do it before the flies hatched. So, since they already hatched, we're going to do it next year. They want to do it as an annual event. Next year, we're going to do it a little earlier. It just teaches the students and the Girl Scouts and the Scouts of America. We also, want to invite children from Nellie Bennett Ocean Road Memorial and science classes and stuff. It teaches them what to look for and how to scrape them off and how to kill the larva before they become flies. Hopefully, that will help us with the fly infestation.

Members of Ocean Space also invited the Historical Society to come and bring some Borough and Beach students to Bennett's Cabin to learn about the history of how Bennett's Cabin became in effect, where it used to be, and how that put over to the Riverfront Park and how they rebuilt it. This was an event that the Open Space held. Also, there's one member in Ocean Space who's also in the Point Pleasant Excellence Foundation and we learned that their Bikes and Barbecue event is going to be held on September 28th. Tickets go on sale June 29th at 9 a.m. and they're sold out by 9.15 a.m. If you want your tickets, get them quick."

Council Member Coulson stated the following: "The tot lot at Riverfront Park has been installed. Unfortunately, the wrong color was installed. The vendor is going to send us the correct color and that will be swapped out once we receive it. I know the little ones are enjoying it, but we want it to match. They've been thanking me a lot.

Good news, the Borough was awarded a \$62,000 Recreation Improvement Grant to replace the swings at River Avenue Beach. That'll be nice. Summer camps will begin on June 24th and run through August 2nd. All the camps are full. Senior fitness will be held, I think I mentioned last month it was going to be at the high school. They have changed it. It's going to be at Nellie Bennett in the all-purpose room instead of the high school. That starts also June 24th.

Finally, I want to thank Sherry Silversmith, who's our recreation director, the DPW, the Borough Police Department and the middle school and high school chorus, who all worked really hard to make Memorial Day event very successful. We were very lucky. We finished just minutes before the downpour of rain. It was unbelievable how bad the downpour was. It was a very nice event, so I just wanted to acknowledge all those people that really put a lot of time and effort into making it so successful."

Council President DePaola stated the following: "Speaking of Memorial Day, for the first time since I've been a council person, I had to miss our Memorial Day ceremony, and I just wanted to wish everybody well. I was home sick with strep throat, so I didn't want to infect anybody, but I did want to extend my congratulations to Officer Logan for being our special military personnel, and just apologize again for having to miss it, because I always look forward to that. Also, the Chamber of Commerce had their Summerfest on June the 4th, and I would just like to thank DPW for their setup and cleanup and doing anything and everything else that needed to be done to keep the area clean. I'd also like to extend my congratulations to the police chief, Adam Picca, and his police department, the explorers and specials who also were there that day to ensure the safety of our residents and the vendors. It was a wonderful family day, and I hope all of you had a chance to come out and enjoy that. And then our Captain Leonhardt graduated from Command and Leadership Academy. Captain Christopher Leonhardt graduated from the Command and Leadership Academy, sponsored by the New Jersey Chiefs of Police Association. The academy was created as a result of the New Jersey State Association of Chiefs of Police traveling to the West Point Military Academy in 1993, where they adapted the West Point Command and Leadership model to the needs of law enforcement. So, we offer our congratulations to Captain Leonhardt for his successful completion of this highly esteemed program. As far as public safety goes, during the month of May, the police department conducted more than 350 vehicle stops as officers continued increased enforcement throughout the town. In conjunction with the motor vehicle enforcement, the police department continues to assign e-bike enforcement details to continue efforts in addressing e-bike violations, and they are also going to be targeting crosswalk violations and to remind drivers to never pass a stop vehicle at a crosswalk. There have been some incidents and some near misses, and we want to just warn drivers to please be careful out there. The kids are almost done with school. The weather is beautiful. People are biking and walking everywhere, and you really need to start paying attention. And finally, heat stroke prevention from our OEM group and our ambulance corps as well as our police department. They are just warning people that the inside of a vehicle gets extremely hot when the car is not running, and pediatric vehicular heat stroke is one of the leading causes of non-crash vehicle-related deaths for children 14 and younger. So, be certain to check your car. Make sure your children are out of the car, and the same goes for pets."

Report of Mayor: "I would like to acknowledge a 30-year employee who retired a couple years ago, Dennis Adametz. He was a great guy. He was a great asset. He unfortunately passed away after a short illness over the weekend. I would like everybody to stand, and let's give him a moment of silence. Thank you.

Good evening. I'll start my report tonight with an apology from the last meeting. I misspoke on the Hardenburg well issue. I read the report approximately four years ago. It was from our town engineer, Bob Forsyth, the Mayor and Council. It was shut down due to the depth of the will that additional regulations and requirements by the DPE added at that time. The council voted to protect the health and well-being of our residents as per the new regulations of the DEP and voted to shut it down due to the changing restrictions. On a different front tonight, you'll see a resolution number 14 regarding the mailing of an estimated tax bill. Due to changes in the Board of Ed financials, we have to adopt an estimated bill since they have amended their budget. Anyone wishing to attend their meeting in regard to this item, they will be having a meeting on June 17th at 7 o'clock, presenting the budget on July 15th for adoption. Their meetings will be at Ocean Road School. In regard to Dennis, the viewing will be Thursday from 4pm to 8pm at Colonial Funeral Hall, Route 88, Brick. Funeral Mass will be Friday at 10 a.m. at St. Peter's.

There will be a repass at our firehouse after. Also, unfortunately, the mother of our court administrator did pass away, Joan Marie Michalkowski. Her viewing will be Saturday, June 15th from 2 to 6 at Colonial Funeral Home on Route 88. And funeral is Monday, 10 a.m. at St. Dominic's Roman Catholic Church, Route 88, Bricktown."

Mayor Sabosik opened the meeting to the public.

Resident, Foster Road - I know the ordinance you just introduced tonight about small wireless things. I tried reading part of it. Are we for it, or against it?

Mayor Sabosik - Councilman Joe Furmato and myself attended a meeting with the representative and our attorney. Basically, each town is forced to accept these instruments of, I guess you say, waves for the phones. So we came up with that ordinance to minimize the number of the towers. And so instead of having one tower for one carrier, these towers can fit up to four carriers. So, we're going to minimize the number of the poles in the Town of Point Pleasant.

Resident, Foster Road - Now, how big are these poles going to be? Is it the size of a telephone pole, or are they going to be on everybody's block?

Councilman Furmato - They're going to be 46 feet high. If you go to the beach, they're putting them in now, Point Beach.

Resident, Foster Road - I don't know the size, but right now there's three or four around town. How many of these are going to be on every block?

Councilman Furmato – 20 right now. And it looks like all of them are on the main roads. Like the mayor said, we're going with multiple carriers because I don't think that one carrier would want to take on the cost of all that. So, if you have Verizon, or T-Mobile and all that, they should get them all to come in and do it. Because I don't know about you, but I don't know where the bars went on my cell phone. It's not like it was. There's only one or two, no matter where you go. And it's the FCC that requires it. We have no say.

Mayor Sabosik - We spent a lot of time on that one, as you can tell.

Resident, Foster Road - One little side note. Brady Avenue finally looks nice. It would be nice if they made the manhole covers even with the paving job.

Mayor Sabosik – They will come back for that. What's happening is, the company that raises the manhole covers are backed up. So, they will be back to raise them.

Resident, Hardenburgh Avenue - So last month, Mr. Mayor, you said you were going to instruct the time engineer to see what could be done regarding the well and the impacts that were going on in the area. You said you were going to make it a short-term and long-term. I was wondering what the outcome was.

Mayor Sabosik - Unfortunately, I'm going to let my attorney handle this.

Borough Attorney, Mr. Connors - The historical review of this particular well on Hardenburg Avenue has revealed the fact that going back to the 1990s, shortly after it was dug and replaced back in 1997, there were a number of contaminants that had been found in the water sampling. As you know, all municipalities are required to sample certain classes of contaminants by virtue of the DEP. Back then, there were volatile organics, those associated with industrial strength or commercial solvents. Then shortly thereafter, there was a whole other class of contaminants that were found to be the MTBEs or gas additives. Then after that, another class of contaminants and tests that were required to be performed, and those contaminants were radionuclides. The problem is the well is so shallow, it's 77 feet, that it's susceptible to any surface-laden contaminants that might be introduced in a potable water system. The municipality had made a decision at that time to close that well so that it would not contaminate other remaining parts of the potable water system. I understand that there has been a problem that's been raised that an issue as to whether the closing of the well has created flooding in the area because of no water being drawn from that area. To my knowledge, it's not been concluded that that, in fact, has taken place because there's other contributing factors to the increase of the water table, including rising tides, seasonal water fluctuations, and such. The borough engineer is now looking into whether there are any other alternatives that might ameliorate flooding conditions in the Hardenburg Avenue area.

The resident asked if there was a timeline on that study. Mr. Connors stated that he is not aware of the timeline.

Resident, Hardenburgh Avenue - Thank you. I'm aware of all the contaminants, particularly PFAS. My second question is one of the reasons it was shut down was for PFAS. Do we know who is responsible for that contaminant? It's not actually occurring. It comes from pollutants.

Borough Attorney, Mr. Connors - My cursory review of the past is that there was and I don't know whether it's the same contaminant. So, I'm reluctant to say that but there was a time when there were NTBEs that were discovered. I'm not familiar with it. I'm not an engineer and I don't have a scientific background.

Mayor Sabosik - I don't know if you read the patch today. Headlines. PFAS is all over. PFAS, Forever Chemicals, widely found in New Jersey water. This basically shows that our decision three and a half years ago to close the well was the right decision for the health and welfare of the residents.

Resident, Hardenburgh Avenue - You read that report by Mr. Forsythe. I read it as well. I do have some concerns or questions about it. For one, it was shut down for PFAS specifically. All the other ones were being appropriately treated.

Mr. Connors - It was the discovery of that that might have been the last straw so to speak, because I think the borough recognized that going forward it was going to be susceptible to any surface laden contaminants. Those that we now know and require for testing and those that we don't know. The more prudent thing was to close the well down since it was only 77 feet. It should be down to a thousand feet. It's nowhere near that.

Resident, Hardenburgh Avenue - I understand. The EPA didn't set the requirements until April of 2024. They gave towns five years to come into compliance. They have two options to come into compliance. They activate a carbon solution and another solution. I don't remember the name of it. I also read the report. I'm not going to get into the particles.

Mayor Sabosik – I also read the report. I'm not going to get into the particles part of this. What I will get into is that part of his report did say that they were going to close it or if we kept it open within the next year we had to comply. If it was over the current standards, we would be in violation of giving clean water to our residents. This council could not take that chance. It also stated that we would have to build a pilot plant before we did anything to the major. The pilot plant would take anywhere from three to four years. We both read the report. Let's talk about the whole report. This was a dynamic situation. The state of New Jersey was bringing out much stricter regs and the council said let's do this for the safety and welfare of the residents.

Resident, Hardenburgh Avenue - Now the state has direction from the EPA is what I'm saying, and a five-year timeline. Things have changed since that report.

Mr. Connors – But the depth of the well has not changed.

Councilman Furmato – I am sorry sir, your five minutes are up.

Seeing no other hands, Mayor Sabosik closed this portion of the meeting.
