STATEMENT BY MAYOR SABOSIK: Pursuant to the applicable portions of the New Jersey Open Public Meetings Act, adequate notice of this meeting has been given. Notice of this meeting of the Governing Body has been posted in the corridor of the Municipal Building, published in the January 5, 2024, edition of *The Ocean Star* and January 5, 2024, edition of *The Asbury Park Press*.

Acting Mayor DePaola stated the following: "Tonight, I am very pleased to announce that we will be hiring two new police officers that will serve the residents of Point Pleasant Borough, and we could not be more proud. I also want to say that I am very sorry that Mayor Sabosik could not be here tonight. He is extremely disappointed that he couldn't be here tonight. He had a minor procedure today and his doctor told him to stay home. I also wanted to thank our PBA president for coming this evening. First off, we have Justin Tuzzolino. He is a Point Pleasant resident who graduated from Point Pleasant High School in June of 2022. Mr. Tuzzolino was involved in the Point Pleasant Varsity Football Team and participated in the Point Pleasant Challenger Program where he assisted children and adults with special needs. He was a former Point Pleasant Police Explorer where he rose to the rank of Sergeant. Mr. Tuzzolino was hired by the Bay Head Police Department as a Special Law Enforcement Officer Class II and graduated from the Ocean County Police Academy in February of 2023. He was a Special Law Enforcement Class II officer with the Point Pleasant Police Department from January 2024 until July 2024 before taking a position with the Ocean County Sheriff's Department. Mr. Tuzzolino wanted to become a full time officer with the Point Pleasant Police Department and took the civil service entry level exam. In November of 2024 the results were released, reflecting that Mr. Tuzzolino came out number one with a score of 99.83. Mr. Tuzzolino was fully certified and will enter a modified field training officer program and upon successful completion will be assigned to the patrol shift. Congratulations."

Acting Mayor DePaola opened the meeting to the public.

Resident: 211 Osborn Avenue - "I have been a resident of Point Pleasant since 1968. I would like to talk about 5G. In today's Ocean Star, there was a very good article about the settlement in Lavallette. They conceded that they do not have the money to fight it. The Judge recommended that they settle and not take this thing to court. One of the councilmembers there, Joanne Filippone, voted no on the 5G. She gave a whole big explanation as to why, and I agree with her one thousand percent. The other item I am bringing up is that Spring Lake is fighting this 5G network which is unnecessary and unneeded. It has nothing to do with cellphones. I read that people want to be able to watch a movie on the beach on their laptop or whatever. So, this concern is ridiculous. I have a flip phone which is in a case and is off, but they still track me. We are living in bad times now. I would recommend our Mayor to get in touch with Spring Lake because they have a private organization to fund the fight against Verizon. Another item I have is that this was sent home to every resident in Point Pleasant. I have said I do not want a smart meter. This looks like a piece of junk mail. There is not even a notification. I have an analog meter. I asked the meter reader about this. If you are sleeping and you have an outlet next to your head, that outlet with smart reader stuff is looking for things to do. I am not an expert, but I am just trying to fight this stuff. I opted out of this, but they are going to charge me \$15.00 monthly. How are they going to charge me \$15.00 a month when since 1968 it has been read by a person and the person who read it two months ago said there are about 600 people who have opted out. Are we going to fight this \$15.00 charge?"

Acting Mayor DePaola: "The utilities are under the control of the BPU in Trenton."

Mr. Pannucci asked what meters he was talking about because it is not from us.

Resident: Stated it was the electric meter.

Mr. Pannucci stated that, that is JCP&L and not us.

Resident: "Well I would recommend that the Borough get in touch with Spring Lake and fight this 5G and maybe even get a class action suit going against Verizon. We need to get serious about taking these people out."

Resident: Foster Road – Wished everyone a Merry Christmas

Resident: Beach Blvd – "Unfortunately, I did not have enough time to do the research that I would like to do, so what I am going to tell you is based on hearsay. I have heard that the crossing guards in town make \$24.00 an hour. That is a higher hourly rate than the two police officers you hired tonight. The workers at the Arthur Avenue Recycling Center make between \$14 to \$15 per hour. I just do not understand that disparity. I feel like they really all have the same skill set. They don't need a PHD or a License or anything. I heard they were promised a .50 cent an hour raise and that was delayed. There is a gentleman there by the name of Dave. His father and his grandfather both worked for the DPW, and I imagine that has to do with how he got in. He had a surgery that was botched and now has a disability. I think it is great that the town has hired him, but I don't understand why the town won't make him full time. I think it would be the right

thing to do. It would show compassion and empathy, and I want to know why you won't hire him full time. I don't understand why he is being held back. I would like a comment on this."

Mr. Dasti stated that the Borough is not going to comment on that. But did state that the hourly rate he spoke about is controlled by contracts and each of those types of employees mentioned all have their own bargaining units.

Resident: Beach Blvd – "Well it is my understanding that the guys who work over at the Recycling Center part-time are not union."

Mr. Pannucci: "First of all, number one, as far as individuals, we do not talk about personnel issues. Number 2, the part-timers, the recycling guys are seasonal, and they are part-time. Crossing Guards have a contracting unit. The PBA, even though they start at that low scale, they also scale up very fast. Faster than any other unit, as per their contracts, which is the case in most municipalities in New Jersey.

Resident: Beach Blvd – "So are you suggesting that the guys who work part-time at the DPW should unionize?"

Mr. Pannucci: "I am not suggesting that at all, I am just simply stating that we do not talk about direct personnel issues with individuals and just explaining our scale."

Seeing no other hands, Acting Mayor DePaola closed this portion of the meeting.

Acting Mayor DePaola stated that there would be no Executive Session this evening.
