Mayor Sabosik: "Jeff was born and raised here in Point Pleasant, NJ. He has dedicated his life to serving the community that has shaped him. His public service journey began in 2006 when he joined the Point Pleasant Borough First Aid Squad and earned his EMT certification. He graduated from Point Pleasant High School in 2009 working as a part-time dispatcher for Point Pleasant Borough. He then went to Sea Girt where he was a Class I and graduated from the Ocean County Academy in May of 2010. He remained in the Sea Girt PD as a Class II gaining experience in various roles. In 2011, seeking to broaden his patrol experience, he joined the Lakehurst PD as a Class II. His commitment and continued growth led him back to Point Pleasant where we were very fortunate to hire him in March 2012 as a full-time police officer. He has pursued higher education and has an associate's degree from the Ocean County College. He has been a chief component with our K-9 Unit and community policing. He lives in Point Pleasant with his young wife Megan, and their three children."

C. WORKSHOP

1. Committee Reports

Council Member Veni stated the following: "I would like to congratulate Sergeant Johnson on his well deserved promotion. Thank you for being an integral part of the Borough Police Department and for helping keep our town safe every day. Congratulations to both Lilian Youseff and Officer Tobias for selflessly putting your own lives second and another person's life first to save them.

Just a quick EC note. The next Environmental Commission meeting is scheduled for Tuesday, August 19, 2025, at 7pm here in the court."

Council Member Stevenson stated the following: "I want to congratulate Sergeant Johnson on your much-deserved promotion. What you do for our town and children is amazing. Thank you for your dedication. To our lifesaving award winners, Lilian Youseff and Officer Tobias, what can I say but thank you.

I recently spoke with our District Assemblyman Greg McGuckin, about a bill he and Assemblyman Paul Kanitra sponsored A1062, which establishes a 15 MPH speed limit for E-Bikes and E-Scooters. They are currently working on getting support from various law enforcement organizations and other members of the assembly. They will keep me updated. Assemblyman McGuckin advised that the Assembly is on summer break, and any legislation will not be acted on until late fall.

I reported at the last meeting that the state health and benefit plan want to increase contributions significantly. The proposed increases range from a single user making \$20,000-\$29,999 up 2.584% to a family plan with an employee making \$110,000+ increases to a flat rate of \$17,500.00 each. The league of municipalities is working hard with various groups, including the legislature, to come up with a different plan. They are not supporting this bill.

School fall sports and band practices have started and will be reopening on September 3rd."

Council Member DePaola stated the following: "First off, I would like to congratulate Jeff Johnson on his promotion to Sergeant of our Borough Police Department. Jeff has been a wonderful addition to our department, and he has worked really hard over the years. It is really a well deserved promotion. And we are all so lucky to recognize Officer Tobias and our resident Lilian Youseff on their courageous and heroic actions in saving someone under distress. Also, I would like to thank our Emergency Management organizations. They responded to 48 incidents in July. They were very active and one of the things that happened in August was our National Night Out, for which I would like to thank our DPW, our Police and our Community Watch Organization and all the local government organizations and non-profits that showed up to help us. And thank you to all our local businesses that were kind enough to donate so that we could have this free event for families and residents of the Borough. Another indication of why we love living here. Everybody worked together really hard, and it was a wonderful event."

Council Member Coulson stated the following: "I would like to congratulate Sergeant Johnson on his well-deserved promotion, and I want to say a big thank you to Lilian Youseff and our own Police Officer Tobias for their life saving efforts. This is what Point Pleasant is about. Community, and people helping people. This could have really had a bad outcome if not for them.

Sadly, summer is coming to an end. Our Fall Recreation programs will be starting soon. The Fall Festival is in October, and then we have Trick or Trunk and Haunts in the Park. I will give you those dates as it gets closer. I am going to savor what we have left of the summer."

Council President Furmato stated the following: "I would like to congratulate Jeff for his promotion to Sergeant. He is a great guy, and I know he is going to do a great job.

On another note, Wednesday this week, bidding goes out for the Herbertsville Road and River Road Sidewalks. And then next Monday we will have a meeting here to award that bid.

2. Report of Mayor

Mayor Sabosik stated the following: "Tonight we will be voting on a new ambulance for our First Aid. We have one of the most active First Aid units in the state. All hours of the day and night, they go out and take care of our residents. We will be retiring an older ambulance. Also, tonight, we have one police interceptor and two Ford Escapes. We are going to two Ford Escapes because we are going to retire 15 year old Crown Vics. The Ford Escapes are going to give us almost double the gas mileage that the Ford Crown Vics used to give us and also gives us two more vehicles with all wheel drive. Hopefully, the Council approves both of those items tonight. I think it is mandatory that we do that.

Also, tonight we will be voting on a settlement from a chemical company which at the end will probably be close to \$400,000.00 for this town. It was through a class action lawsuit that we became part of, and we have not spent any dollars for the attorney. It is a national firm that is doing it. We will be getting the money over the next six years.

As Council President Furmato stated, we are going to have a special meeting next week. But we also had meetings with New Jersey DOT where they are coming out with the largest maintenance contract in their history for Route 88 Improvements. This will have bike lanes, walking lanes and rapid rectangular flashing beacons, which is what we have at the park. This is vital for the future of our town. We are making the town safer. We are improving the walkability, and we will continue to do these improvements."

Mr. Dasti: "It didn't affect our well water, just the pollution in the ground. There was never any threat to the health of residents in town."

Mr. Pannucci: "It is stemming off of the styrofoam and the fire extinguishers from the Brick Township Fire Academy on Herbertsville Road in Brick. Because it is close enough to our proximity, we were able to join the national lawsuit against Dyson, Dupont and all those firms that manufactured those chemicals to recoup some of the costs that we naturally had to use. So, it is free money for us. Mr. Dasti did an amazing job getting us that free money. And the Mayor and Council."

Mr. Dasti: "Here is an interesting story about that. We retained a nationwide firm to do this on a contingency basis. The name of the firm was Kennedy & Madonna. And Kennedy was Robert Kennedy Jr. So, he was the partner in the firm. His name is not on the letterhead anymore because he has got other things going on. I talked to Kevin Madonna quite a few times. Their office is outside of New York City in a small town in New York State. I asked him why they are not in the city being such a big firm. He then explained that they were all set to go into the city and open offices there in the city. We were going to move in on September 12, 2001, to the Twin Towers. I have never been back."

Resident: 2117 Foster Road - Asked which post John Kaklamanis will be a crossing guard at.

The Council responded that that would be up to the Chief.
