**3 YEAR DOG LICENSE RABIES VALID THROUGH NOVEMBER 1<sup>st</sup> 2028**  
DOG SPAY/NEUTERED: \$ 33.00 +LATE FEE \$ 5.00 EACH AFTER JANUARY 31<sup>st</sup> ++  
DOG NON-SPAY/NEUTERED: \$ 42.00 +LATE FEE \$ 5.00 EACH AFTER JANUARY 31<sup>st</sup> ++

**1 YEAR DOG LICENSE RABIES VALID THROUGH NOVEMBER 1<sup>st</sup> 2026**  
DOG SPAY/NEUTERED: \$ 12.00 +LATE FEE \$ 5.00 EACH AFTER JANUARY 31<sup>st</sup> ++  
DOG NON-SPAY/NEUTERED: \$ 15.00 +LATE FEE \$ 5.00 EACH AFTER JANUARY 31<sup>st</sup> ++
